THREE THINGS You Should Know:

1 Applications are open for the Arts Project Support grant program, which is administered by The Arts Federation through the IAC's Regional Arts Partnership Program. These grants provide funding to nonprofit organizations for arts programming. First-time applicants are welcome to contact TAF to request a review of their application draft before February 23. Arts Project Support grants provide funding to nonprofit organizations to support a specific part of the organization's arts activities, such as a one-time event, a single production, an exhibition, an educational workshop, or a series of related arts activities such as art classes or training sessions. Applications must be submitted through the IAC's online grant system no later than March 9, 2022.

Ask Rusty – Do Medicare Part A and B Backup My Medicare Advantage Plan?

Dear Rusty: I was told that I can use Medicare Parts A and B as secondary coverage to my Medicare Advantage plan. Is that true? **Signed: Puzzled**

Dear Puzzled: Many do not understand how the various parts of Medicare work, and especially how or if "original Medicare" (Medicare Part A and Part B) interacts with a Medicare Advantage plan. If you now have a Medicare Advantage plan, it is the private insurer who provides your plan that administers all of your healthcare needs, instead of the federal government agency which runs Medicare (that federal agency is called the Centers for Medicare & Medicaid Services, or "CMS").

Although you must pay Medicare Part A and Part B premiums to the federal government to obtain a Medicare Advantage plan, all your healthcare services are handled by the private Medicare Advantage plan provider

and not by the government's CMS agency. When you have an Advantage plan, Medicare Parts A and Part B do not act as secondary coverage for your Advantage plan. You don't get healthcare services from both, because when you choose a Medicare Advantage plan you are deselecting CMS as the administrator of your healthcare needs.

Deciding whether to use "original Medicare" to administer your healthcare services or to use a Medicare Advantage plan is always a very personal choice. Medicare Advantage plans

cover almost all the medically necessary services that original Medicare covers, although you must generally use "in-network" providers to obtain full coverage. But if you incur healthcare expenses which are not covered by your Medicare Advantage plan, you must pay them yourself - federal Medicare Parts A and Part B are not backup coverage for those uncovered healthcare expenses. So, what you were told is incorrect - Medicare Part A and Part B do not act as secondary coverage to your

Protecting Your Lungs Can Start With A Scan

(Family Features) Not too long ago, smoking used to be everywhere. In fact, many people remember the days before there were even smoking and non-smoking sections in restaurants. People who smoked and others who didn't mingled in the same dining room. They sat side-by-side on a plane. Some rode in the backseat of a smoke-filled car, and no one gave it a further thought.

Today, things are done differently. However, those memories can be an important indicator for those who smoked back then to advocate for their health with a lung screening.

Importance of Early Detection

Lung cancer has the highest mortality rate among cancers, killing men and women more than any other type. If found in its earliest stage, however, lung cancer is more likely to be successfully treated, ac-

You Can Have A Porterhouse Steak As Long As It's Rare – A Rare Treat

It sometimes seems that the world is determined to classify senior citizens as an endangered species, telling us that we need to exercise more in order to keep in shape and eat foods not because they are tasty but because they're good for you, says Rebecca Weber, CEO of the Association of Mature American Citizens [AMAC]. "They are right, of course, whoever 'they' are. But does that mean we can't take an occasional break -- that we can't take it easy every once in a while or have a meal not because it is particularly good for you but because you crave the flavor?"

Certainly you should consult your healthcare provider when it comes to questions about exercise and nutrition, stresses Weber. "Who knows, you may find that your workouts do not have to be as excessive and exhausting as you might think. You may also learn that it's okay to have a real steak instead of a Grilled Tofu Steak with Piquillo Salsa Verde, as

suggested by the folks at Food and Wine."

There's a lot of research out there that shows we, old timers, should heed our MDs when it comes to activities that can have an impact on our health, says Weber. But there is also a lot of research that indicates you might be able to skip a healthy meal on occasion in favor of a Porterhouse steak, for example. But it's recommended that you choose a steak that is lean and that you don't overdo it.

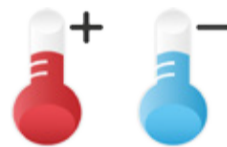
Julia Zumpano, a Registered Dietician at the Cleveland Clinic, says "When you prepare red meat, focus on dry cooking methods, like baking, broiling, grilling, roasting, poaching or air frying." She also recommends that you should limit the amount you eat to one or two servings of six ounces or less per week. And, she says, limit yourself to less than three ounces a week if you have heart disease and/or high cholesterol. But,

She was born Sept. 18, 1968 in Danville, Ill. to Kenneth Anders and Nell Carter Sheridan

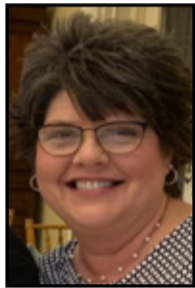
She was active in her church, Calvary Chapel Crawfordsville and so loved serving her Jesus.

US Dept. Of Labor Provides States With Updated Guidance To Waive Recovery Of Unemployment Insurance Benefits Overpayments

During the height of the pandemic, records were broken as millions of Americans filed claims for unemployment benefits. As demand soared, the U.S. Department of Labor provided instructions to states to administer payments under several programs authorized by the Coronavirus Aid, Relief, and Economic Security Act. As guidance evolved, states paid benefits - in some cases - to individuals who were not entitled to receive them, although the individuals were not at fault.

The department issued an Unemployment Insurance Program Letter to states to address overpayments under the CARES Act's Unemployment Compensation Programs

when the claimant is not at fault. The updated Unemployment Insurance Program Letter augments guidance the department issued on May 5, 2021.

In recognition of the enormity of the challenge the pandemic placed on claimants and State Workforce Agencies, the department's Employment and Training Administration updated its waiver guidance to approve five new scenarios under which states may apply blanket waiver of recovery of overpayments:

- An individual responded "no" to being able and available for work and the state issued payment for Pandemic Unemployment Assistance or Pandemic Emergency Unemployment Compensation without

adjudicating the eligibility issue.

- An individual was eligible for payment and the state issued payment at a higher rate Weekly Benefit Amount under the Pandemic Unemployment Assistance or Pandemic Emergency Unemployment Compensation program.

- The individual responded "no" to being unemployed, partially unemployed or unable or unavailable to work due to the approved coronavirus-related reasons, and the state paid Pandemic Unemployment Assistance. When asked to self-certify, the individual did not respond or confirmed that none of the approved coronavirus-related reasons applied and the state issued payment, resulting in over-

payment for the week.

- The individual submitted required proof of earnings used to calculate Pandemic Unemployment Assistance Weekly Benefit Amount and the state incorrectly processed the calculation resulting in a higher weekly benefit amount under the PUA program.

- The individual submitted proof of self-employment earnings to establish eligibility for Mixed Earners Unemployment Compensation Program and the state incorrectly processed the information, resulting in overpayment.

When states waive recovery of overpayment, collection activities cease. Fraudulent overpayments remain exempt from waiver and must be repaid.

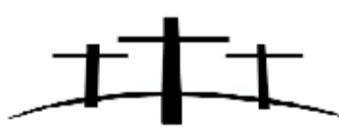

Louisiana could receive up to \$73.4 million for electric vehicle chargers under a new infrastructure law.

The U.S. Department of Transportation announced Thursday that nearly \$5 billion would be made available to states under the new National Electric Vehicle Infrastructure (NEVI) Formula Program.

The law, established by the Biden Administration, would build out a national electric vehicle charging network to making electric vehicle (EV) charging accessible to all Americans.

In Michigan: The Detroit News: Michigan to get \$16.3 million from feds to build electric vehicle chargers

Michigan is expected to receive \$16.3 million to build electric vehicle chargers, the Biden administration announced Thursday.

It's the first round out of nearly \$5 billion in formula funding over five

years to build a nationwide network of DC fast chargers, approved as a part of the new bipartisan infrastructure law.

Officials expect the funding to hit state coffers in August or September, after state spending plans are approved by federal officials.

The chargers should be primarily along "alternative fuel corridors" designated by the Federal Highway Administration that can quickly accommodate chargers.

In North Carolina: Fox8: Feds to build electric-vehicle charging stations along interstate highways

The federal program announced today, part of the \$1 billion bipartisan infrastructure bill approved by Congress last year, requires states to have such plans in place before they can tap into the \$615 million that is available this year. That's how North Carolina was designated to receive \$16,137,196.

In Ohio: WKBN: Biden providing \$140M for EV charging stations in Ohio

The U.S. Department of Transportation announced in a press release Thursday that the Biden administration will be providing \$140.1 million to go towards an electronic vehicle charging network

for Ohio. The release states that \$5 billion will be available under the new National Electric Vehicle Infrastructure (NEVI) Formula Program to usher in electric vehicle charging infrastructure.

In Pennsylvania: WHTM: Infrastructure Law gives Pa. \$171.5 million for EV chargers

"Americans need to know that they can purchase an electric vehicle and find convenient charging when they are using Interstates and other major highways," said Deputy Federal Highway Administrator Stephanie Pollack. "The new EV formula program will provide states with the resources they need to provide their residents with reliable access to an EV charging station as they travel."

This is all part of the Biden administration's plan to utilize widespread adoption of zero-emission vehicles.

In Texas: Houston Chronicle: Biden moves to build coast to coast network of electric car chargers

The Biden administration is moving to create a nationwide network of electric vehicle chargers that would enable Americans to drive long distances without concern for running out of power.

With \$5 billion in funding from last year's bipartisan infrastructure bill, the administration is asking states to submit plans for developing electric charging routes along interstates and state highways. Texas, with its vast network of roadways, is

expected to get more than \$400 million in funding, more than any other state.

"A century ago, America ushered in the modern automotive era; now America must lead the electric vehicle revolution," U.S. Transportation Secretary Pete Buttigieg said in a statement.

In Utah: Deseret News: President Biden rolls out \$5 billion in funding for electric vehicle chargers

Charging stations for electric vehicles are few and far between, unlike gas stations. But that may change soon if President Joe Biden's plan is successful.

According to Reuters, the U.S. Department of Energy and Transportation announced on Thursday that it will roll out \$5 billion over the next five years to help states set up more charging stations for electric cars in an effort to hit zero emissions from vehicles.

In Indiana: Fox59: Indiana gets funding to expand electric vehicle charging network

As Indiana continues its infrastructure development under the Biden administration's infrastructure law, leaders now have an opportunity to expand the state's electric vehicle infrastructure.

Under the new National Electric Vehicle Infrastructure Formula Program, Indiana is eligible for up to \$99.6 in funding for projects directly related to the charging of an electric vehicle (EV) and support EV charging infrastructure. The goal of the program is to make EV charging accessible to all Americans.



US Department Of Labor Seeking Public Comment On Protecting Workers' Life Savings

The U.S. Department of Labor today announced publication of a Request for Information seeking public comment on what actions, if any, the department should take under federal law to protect retirement savings and pensions from risks associated with changes in climate.

The RFI follows President Biden's Executive Order on Climate-Related Financial Risk which directs the department to identify actions it can take under the Employee Retirement Income Security Act of 1974, the Federal Employees' Retirement System Act of 1986, and other relevant laws, to safeguard the life savings and pensions of U.S. workers and families from the threats of climate-related financial risk. Together, ERISA and FERSA provide oversight to more than \$13 trillion in assets.

Published by the department's Employee Benefits Security Administration, the RFI enables the public to help inform any potential future departmental work to secure retirement savings as directed by the executive order.

"The public and stakeholders in general

are a valuable source of information for us. They can help us identify and explore actions to take to better protect the hard-earned retirement savings of America's families," said Acting Assistant Secretary for Employee Benefits Security Ali Khawar. "We encourage all interested parties to submit comments, and to share their thoughts and ideas."

The RFI solicits general input on agency actions that can be taken under ERISA, FERSA and other relevant laws, and poses specific questions related to data collection and fiduciary issues under ERISA, the federal Thrift Savings Plan under FERSA and other miscellaneous topics. The RFI follows a proposed rule published by the department, Prudence and Loyalty in Selecting Plan Investments and Exercising Shareholder Rights. The RFI deals with a broader set of questions than the proposed rule and is a different initiative.

The RFI's comment period will run for 90 days after publication in the Federal Register and the RFI includes instructions on how to submit comments.

Senate Democrats' Proposal To Suspend The Federal Gas Tax

Construction Official Says "Irresponsible" Proposal Won't Address Root Causes of Higher Fuel Prices, But Will Blow a Huge Hole in the Federal Highway Trust Fund and Undermine Efforts to Fix Infrastructure

The chief executive officer of the Associated General Contractors of America, Stephen E. Sandherr, issued the following statement today in response to the introduction of a bill by several Democratic Senators to suspend the federal gas tax for the remainder of 2022 in response to rising fuel prices:

"A recently introduced proposal to suspend the federal gas tax will likely have no impact on what motorists pay at the pump, but it will certainly make it harder for President Biden to keep his promise to fix roads and bridges that are in desperate need of improvement across the

country. That is because the irresponsible measure, if enacted, would leave a massive hole in the federal Highway Trust Fund, which is largely funded by the gas tax, that pays for federal investments in road, bridge and transit improvement projects.

"Fuel prices are rising for a variety of reasons, including the fact demand is up while Democrats in Congress and the White House are pushing measures to limit domestic oil production. Those factors have led to significant increases in the price of

fuel, and will not go away even if the federal fuel tax were to be temporarily waived.

"Instead of helping motorists, this ill-conceived proposal will make the cost of shipping and commuting higher as growing congestion and worsening road conditions delay shipments, damage vehicles and undermine economic growth since there will be fewer funds available in the long-term to

repair our transportation systems. Ultimately, all taxpayers will be forced, via new taxes or additional deficit spending, to pay for this proposal to plug the massive revenue holes it will create.

"We hope this proposal goes nowhere but we take nothing for granted. That is why will take every possible step to educate members of Congress about why this proposal must not pass."

cording to the American Cancer Society. In fact, detecting lung cancer in its early stages can make the survival rate as high as 90%.

"Unfortunately, lung cancer symptoms typically don't show up until the disease has advanced and when they do appear, they can be similar to common respiratory illnesses with cough, shortness of breath or pain in the chest, back or shoulders" said Dr. Ella Kazerooni, professor of radiology and internal medicine at the University of Michigan and chair of the American Cancer Society National Lung Cancer Roundtable.

"Screening detects lung cancer when there are no symptoms. That's why it's important for people at high risk of lung cancer to get annual lung scans to help increase the likelihood of catching cancer early when it's most treatable. A lung cancer screening is a painless evaluation that

usually takes minutes to complete."

However, according to a study published in the "Journal of the National Cancer Institute," the national average of at-risk individuals getting screened is only 5%.

In 2021, the U.S. Preventive Services Task Force (USPSTF), a panel of national experts in disease prevention and evidence-based medicine, updated guidelines for who is eligible and recommended for annual lung screening. However, the Epic Health Research Network reported 87% of at-risk individuals eligible for screening based on the USPSTF guidelines didn't receive an annual screening despite it being covered by insurance.

What is a Lung Cancer Screening?

A lung cancer screening is a preventive health check, like a mammogram or colonoscopy. It checks the lungs and looks for any changes

from year to year. If there's something unusual in the lungs, a screening can help detect it at an early stage.

A low-dose computed tomography (LDCT) scan is the only method recommended for lung cancer screening in high-risk patients. A LDCT machine takes a 3D picture of the lungs. This type of scan uses 75% less radiation than a regular CT scan and doesn't require the use of needles. Often, there are no symptoms of lung cancer. A LDCT scan can find something before patients know it's there because the symptoms are easy to mistake or don't appear until the cancer is well advanced.

Who's Eligible for Screening?

Lung cancer can affect anyone. A family history of lung cancer, a personal history of lung disease, lifestyle or environmental factors can put a person at elevated risk. Most importantly, a person's

age and smoking habits can be an indicator of whether he or she should consider screening.

More people now qualify for yearly LDCT scans, according to the updated guidelines published by the USPSTF. The guidelines lowered the eligibility threshold based on a person's age and smoking habits. An annual LDCT screening is recommended for people who meet this criteria:

- 50-80 years old
- Actively smoke or have a history of smoking within the last 15 years
- Heavily smoke or used to heavily smoke (people who have smoked for 20 "pack years" or more)

Pack years are determined by the number of cigarette packs smoked per day by the number of years a person has smoked. For example, smoking one package per day for 20 years equals 20 pack years.

If you're concerned about your risk, have a history of smoking and lived through the time when smoking was everywhere, don't wait for symptoms to bring up the subject with your doctor. Talk to your health care provider to discuss the benefits and risks of screening and find out if a scan is right for you.

Questions to Ask Your Doctor About a Lung Cancer Screening

If you're concerned about your risk, have a history of smoking and lived through the time when smoking was everywhere, don't wait for symptoms to bring up the subject with your doctor. Schedule an appointment to talk to a provider and see if you qualify for a scan or could benefit from annual screenings.

Many organizations, including the American Cancer Society, recommend lung screening as an opportunity to identify lung cancer in its early stages, but screening isn't for everyone. A low-dose computed tomography (LDCT) scan is the only method recommended for lung cancer screening in high-risk patients.

When discussing yearly lung cancer screenings with your health care provider, it may be helpful to take notes during your appointment, or you may want to have someone with you to listen and ask questions. Consider asking questions such as:

□ Is lung cancer screening recommended for me?

□ How do I know if my insurance covers LDCT screening?

□ What are the benefits and risks of LDCT screening?

□ How will I get the results of my LDCT scan?
