

student the desire and discipline to attain one's goals and prepare for the future, and he set high standards that he expected everyone to achieve. Ed did use his paddle if a pupil got out of line, but he was fair to all students and loved them as a father. One former student told me, "I will always remember Mr. Miller the best. During the afternoons, when we had studied enough and were getting restless, Ed would suddenly announce that it was time for judgeball, ciphering matches, spelling bees, or ghost stories."

When Ed came to Darlington in the fall of 1915, the school had lost some of its enthusiasm for basketball. There had been no teams for three years, but

Info About Pandemic-Related **Emergency SNAP Benefits**

In March 2020, the U.S. government allowed the state of Indiana to issue "emergency allotments" to help Supplemental Nutrition Assistance Program households during the COVID-19 pandemic. This allowed SNAP families to receive the maximum benefit allowed based on the number of people in the household. For many Hoosiers, this meant they received more SNAP benefits than they would have under non-emergency conditions.

Due to the end of the state public health emergency on March 3, 2022, and a recent change in Indiana law, the last month that Hoosiers will receive emergency

enhanced SNAP benefits is May 2022.

Beginning in June 2022, the SNAP benefit amount a household receives will again, as it was before the pandemic, be based on eligibility factors - household size, income and allowable deductions.

Receiving an eagerly awaited blue envelope in the mail is a rite of spring for thousands of fans of "The Greatest Spectacle in Racing." But why are the envelopes blue?

In the 1970s, Indianapolis 500 tickets were mailed in brown envelopes with the IMS return address in the upper left corner. In the 1980s, a heavier-stock, gray-colored envelope was introduced to mail the tickets, with just the IMS Post Office box number in the upper left corner. A computerized printer also was used for the first time in the 1980s to print ticket customers'

envelope.

When the NASCAR Cup Series was added to the IMS schedule in 1994, the Ticket Office needed a way to distinguish between the envelopes containing tickets for the Indianapolis 500 and the annual NASCAR race, especially if the Postal Service returned the envelope as non-deliverable.

So, the IMS Ticket Office decided to color-code the ticket envelopes for each event. Indianapolis 500 ticket envelopes became blue, Brickyard Weekend envelopes became purple, GMR Grand Prix envelopes became green, and ticket envelopes for other IMS events use a variety of colors, including red, cream, gray and yellow.

During the past two years, COTA has successfully developed and leveraged virtual fundraising tools with outstanding outcomes. Each COTA family depends on their volunteers' ability

to raise funds for transplant-related expenses and the safety net COTA provides. However. sometimes these efforts need to be supplemented with targeted grants and funds. Grants from businesses like Walgreens help to ensure patient needs and access to critical medications are met. During the pandemic, \$6.7 million overall has

been allocated to more than 1,500 COTA families. Lofgren anticipates that during 2022 COTA will pay approximately \$3.6 million in transplant-related expenses, with \$300,000 of that for prescription medications.



Therapy Dog Who Served The Military Is In Need Of Rescue

Musket is a brave and loving street dog who was formally adopted from a pound as part of an innovative program to help U.S. troops stationed overseas. His inspirational journey saw him rise through the ranks and into the hearts and minds of soldiers when he became the first recognized Behavioral Health Service Canine on the Middle Eastern base. But when Musket faced the grim prospect of euthanasia, Paws of War jumped into action to make sure that didn't happen.

The training to make it into the program was hard, but Musket was a natural, and he took on the role as though he knew it was his life's purpose. CPT. H had a new prescription for whatever troubles a soldier was facing: Go pet Musket. The devoted pup thrived among his military family and they



loved and appreciated him for giving them a break from the monotony of deployment, and reminding them of their own pets back home. Though new and shortlived, the program was a

huge success. When the program was unexpectedly terminated, the order came through that Musket's status had been revoked, and with it, the devastating news that he was being stripped of his DoD identification. Despite everything he had done, Musket was once again considered to be a stray dog, and in line with military policy he had to leave the base immediately. There was nowhere

for him to go but back to the pound and his life hung in the balance.

Desperate to save Musket, CPT H reached out to Paws of War and action began immediately to start the process of getting Musket to safety. He was flown to a foster caretaker in Canada where he completed the CDC required 6-month quarantine to be able to enter the United States. Now he is ready for this final part of his journey - reuniting with CPT H and moving into his Stateside forever home.

"We are only able to help our military members and the animals they love thanks to everyone who supports our

mission," said Misseri. "Musket is invaluable to those in need and we cannot let his therapeutic service come to an end. He thrives in helping and strives to do his best - he has more than earned a safe place. We are doing everything we can to make that possible for him here in America"

Ed changed all of that. Ed had played football for Wabash College. His mother was part Miami Indian, and with his straight black hair, rugged profile, and muscular build, he earned the nickname "Indian Ed" from his Little Giant teammates. The students and players loved Ed so much that they adopted his college nickname as the Darlington team name... the Indians. Fritz Miller, one of Ed's sons, became the first mascot for the school, and the school elected its first cheerleaders for pep sessions and games. Ed produced some outstanding teams from 1916-23, and several of his high school players later became members of the Darlington Bearcats independent team after graduation. He retired from coaching after the 1923 season, but came back to coach for three years in the late 1920s. His last coaching stint was for two years during WWII, when coaches were hard to find because so many young men had joined the military.

Ed retired from teaching in 1944, but he substitute taught in the small schools in the county before later moving to Florida. According to former teacher (and banker) John Bower-
