1 The Indiana Department of Transportation announces State Road 236 will close in both directions on or after Friday, June 10 between N. County Line Rd. 900 E. and West St. near North Salem for construction work. Starting July 19, S.R. 236 will close between U.S. 231 and Rush St. in Roachdale for additional work in Putnam County. The official detour follows S.R. 75 to U.S. 36 to U.S. 231 back to S.R. 236.

2 At last someone has come up with a way to eat a burrito without it falling apart, says the Association of Mature American Citizens [AMAC]. - Your wife's minor children will all be eligible for a survivor benefit, which will be based upon the Social Security benefit

Assisted living facilities are not an option for those who want to socialize with neighbors, family and friends, are able to get around on their own and feel safe and secure in their own homes.

A poll conducted by Capital Caring Health, a nonprofit provider of elder health, and the online health website, WebMD,

found that "88% of people between the ages of 50 and 80 said it was very or somewhat important to them that they live in their homes as long as possible." But the reality is that not all of them are prepared.

"Aging in place is trending due in part to the fact that growing old is not as debilitating as it used to be," says Gerry Hafer, Executive Director of the AMAC Foundation, the

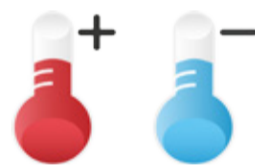

She married Richard 'Dick' Fulwider March 22, 1964 in Liberty Chapel Church and he preceded her in death Sept. 14, 2018.

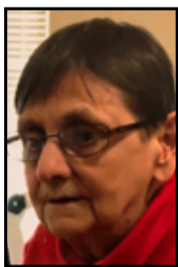

The Whalemobile Is Coming To The Ladoga-Clark Twp. Public Library June 17

Cynde McInnis, owner of The Whalemobile, will be bringing her life-sized (43 ft.) inflatable whale, Nile, to Ladoga-Clark Twp. Public Library as part of our summer reading program, Oceans of Possibilities. The program is scheduled for June 17th with half hour slots, at 2:30, 3:00 and 3:30 PM.

Children will meet Nile, a 35-year old humpback whale whom McInnis has seen almost every summer since 1994 off the coast of Massachusetts. They can go

inside of the inflatable whale and learn about how whales are similar and different to humans. Students will learn about Nile's migratory path, how many calves she's had, as well as how researchers learned this information. Artifacts such as baleen, teeth and bones are available for children to see and feel. At the end of the presentation, they will be encouraged to become Playground Protectors and see how much trash they can collectively pick up this summer!

2022 is McInnis' 29th season working on whale watch boats. She is currently a naturalist with 7 Seas Whale Watch out of Gloucester, MA. Having studied whales in the Atlantic, Pacific and Indian oceans, she brings her passion for whales as well as her vast knowledge of these animals into schools and libraries to help cultivate the next generations of ocean advocates.

The Whalemobile aims to captivate students and help them connect with the oceans, both emotion-

ally and intellectually. Students will come away with knowledge of and a fascination for whales that will be the spark that inspires them to care about the oceans and the environment around us.

Seantors Young, Brown Bipartisan Resolution Passes The Senate, Recognizing The Work Of Child And Youth Advocates Across The Country

U.S. Senators Todd Young (R-Ind.) and Sherrod Brown (D-Ohio) announced the passage of their bipartisan resolution recognizing specially trained volunteers who advocate in courtrooms and other settings on behalf of child survivors of abuse, neglect, and abandonment, which passed the Senate at the end of May.

The CASA Volunteers' Day Resolution honors Court Appointed Special Advocate (CASA) and Guardian Ad Litem (GAL) volunteers for their life-changing work with children experiencing abuse or neglect. This resolution recognizes June 6th as "CASA/GAL Volunteers' Day."

"Indiana is lucky to have CASA/GAL volunteers serving 88 Hoosier counties to give every child the opportunity to thrive. It's our job to

make sure these volunteers are supported so they can continue to positively change the lives of our nation's most vulnerable children," said Senator Young.

"Every young person deserves a safe and stable place to call home—and so many more have that home now, thanks to the work of Ohio's CASA/GAL volunteers. Even in the midst of a pandemic, volunteers in Ohio served almost 10,000 children last year and continue to play a vital role by helping protect and support foster youth every single day. We must honor them, and continue working to ensure they have the resources to uplift the voices and needs of children in their communities," said Senator Brown.

"We are grateful to Senators Sherrod Brown and Todd Young, as well

as Representative Katie Porter, for their bipartisan support in recognizing today as the 2nd annual CASA/GAL Volunteer's Day through resolutions in the Senate and House. Together with our valued collaborator, Unbelievably Resilient, we seek to amplify the voices of youth with lived experience in the foster care system and hope that today people nationwide will have the chance to better understand the critical role a CASA/GAL volunteer plays in the lives of young people. Dirty Dozen: Dangerous Spear Phishing Attacks

The Internal Revenue Service today announced that spear phishing is the 8th item on the 2022 "Dirty Dozen" scams warning list and a serious problem because it can be tailored to attack and steal the computer system credentials of any small business with a client data base, such as tax professionals' firms.

"Tax professionals generally relax a little after filing season and many take a well-deserved vacation but don't let your IT defenses down," said IRS Commissioner Chuck Rettig. "Spear phishing remains one of the biggest threats to the tax industry and other client-based enterprises."

Spear phishing is an email scam that attempts to steal a tax professional's software preparation credentials. These thieves

try to steal client data and tax preparers' identities in an attempt to file fraudulent tax returns for refunds. Spear phishing can be tailored to attack any type of business or organization, so everyone needs to be on the lookout and not rush to act when a strange email comes in.

The IRS has compiled the annual "Dirty Dozen" list for more than 20 years as a way of alerting taxpayers and the tax professional community about scams and schemes. The list is not a legal document or a literal listing of agency enforcement priorities. It is designed to raise awareness among a variety of audiences that may not always be aware of developments involving tax administration.

"Dirty Dozen" scams tend to be most prevalent

during the filing season but criminals are busy all year long.

The IRS, state tax agencies and the nation's tax community – working together as the Security Summit – continue to see an increase in this scheme attacking the tax professional community.

The latest phishing email uses the IRS logo and a variety of subject lines such as "Action Required: Your account has now been put on hold." The IRS has observed similar bogus emails that claim to be from a "tax preparation application provider." One such variation offers an "unusual activity report" and a solution link for the recipient to restore their account.

Emails claiming "Your account has been put on hold" are scams. The

scam email will send users to a website that shows the logos of several popular tax software preparation providers. Clicking on one of these logos will prompt a request for tax preparer account credentials.

The IRS warns tax pro not to respond or take any of the steps outlined in the email. Similar emails include malicious links or attachments that are set up to steal information or to download malware onto the tax professional's computer.

In this case, if recipients enter their credentials into the pop-up window, thieves can use this information to file fraudulent returns by using credentials that were provided by the tax professional. For more information, see IR-2022-36.



benefit she had earned until she died) but, since there will be three children collecting, the Family Maximum will apply. The Family Maximum limits total survivor benefits to between 150% and 180% of your wife's PIA. Typically, with 3 survivors, the Family Maximum should come out to about 175% of your wife's PIA. Social Security will determine these numbers when you apply for benefits for the children, which you should do by calling 1.800.772.1213, or making an appointment at your local SS field office (find it at www.ssa.gov/locator). The funeral

home which handled your wife's arrangements will send a copy of her death certificate to Social Security, but SS will probably require you to provide each child's Social Security number and birth certificate, and you may also need to provide your wife's death certificate if they ask for it. As each child becomes age-ineligible for minor child benefits, the benefit for each remaining minor child will automatically increase, up to their maximum 75% of your wife's PIA.

- Because your children are minors, you will need to act as their Representative Payee. Social

Security will guide you through that when you contact them to apply for benefits for the children, but it essentially means that their benefits will be paid directly to you and you will be obligated to use that money on behalf of the children. You can review Social Security's Representative Payee rules at this link: www.ssa.gov/payee/.

- Regardless of your age, as your wife's surviving spouse with minor children you could be eligible for a "child in care" surviving spouse benefit until the youngest child is 16, but you should be aware of the following:
 - o If you are working

full time, you probably will be ineligible for child-in-care spouse benefits because of your earnings. Social Security imposes an earnings limit for those collecting early spousal or survivor benefits.

- o If you are eligible for child-in-care benefits and collect the same, it would detract from the benefit amount each of your children will get because of the Family Maximum discussed above. In other words, the Family Maximum amount (which Social Security will determine based on your wife's PIA) is the total amount that can be paid out on your wife's

record, regardless of how many survivors are collecting.

As your wife's spouse, you will also be entitled to a one-time lump sum death benefit of \$255, which you can request when you speak with Social Security. Once again, please accept our condolences on the loss of your wife. I hope the above information is helpful at this difficult time.

seeking to ensure more people live, work and go to school in asthma-friendly environments. Here's what to know:

1. Understanding triggers. Asthma triggers can cause symptoms and if left untreated, could lead to an asthma attack. Common asthma triggers include respiratory infections, allergens, irritants, exercise and emotions. Indoor triggers found at home, school and workplaces include tobacco smoke, dust mites, pests such as cockroaches and mice, mold, cleaning chemicals, dust, gases, vapors and fumes. Common outdoor asthma triggers include pollen, wildfire smoke, ozone and particle pollution.

2. Reducing home triggers. People spend over 90% of their time indoors and most of that time is in their home. Whether you rent or own your home, you can make these changes to improve

the quality of the air you breathe:

- Run the bathroom fan after showers and use the kitchen fan while cooking to control moisture and other air pollutants.
- Use vacuums with good filtration, such as a HEPA filter.
- Properly store food and other items that attract pests.
- Make your home (and vehicle) smokefree.

- o Additional actions you can take include improving ventilation, maintaining HVAC systems and using integrated pest management. If you rent, some of these solutions would be the responsibility of the landlord. Learn more about how to improve the indoor air quality of your home as a tenant by reviewing the guide developed by the Environmental Law Institute found at eli.org.

3. Taking action for children. Children's respiratory systems are still

developing, making them particularly vulnerable to air pollution. However, 95% of American school buses are diesel-powered. To learn more about how to advocate for your school district to modify older diesel school buses or transition to zero-emission electric school buses, visit lung.org.

4. Healthier workplaces. About one in six cases of adult-onset asthma can be linked to the individual's occupation and about one in five adults with asthma experience worsening of symptoms because of where they work. Missed workdays and lost worker productivity due to asthma can be costly for individuals who live with asthma and employers. By establishing lung-friendly workplace policies and offering an employee asthma education program, employers can help employees and family members with asthma better

manage their conditions and experience fewer symptoms. If you have asthma or are a caregiver for someone with asthma, consider speaking to your employer about instituting policies that promote a safe, healthy workplace.

5. Additional guidance. The Centers for Disease Control and Prevention's National Asthma Control Program developed "EXHALE" a set of six strategies that help contribute to better asthma control. The strategies can help you and your loved ones have fewer asthma symptoms, prevent emergency visits to the hospital and help you avoid missing school or work. To learn the strategies and for additional resources, visit cdc.gov. You can also check out the range of asthma programs and initiatives offered by the American Lung Association that align with the EXHALE strategies by visiting lung.org/AFE.

non-profit arm of the Association of Mature American Citizens. "The acceptance of healthier lifestyles and the benefits of modern medicine have helped to convince many seniors to stay at home."

There is a caveat, of course, says Hafer, and that means you need to make an assessment of what you are able to do by yourself and what you can't do. "The most critical issue you need to deal with is your health. Do you suffer from a debilitating illness? In fact, making the decision may require a conversation with your doctor."

Here's a checklist courtesy of the National Institute on Aging [NIA]:

- Are you able to take care of yourself by yourself?
- Do you need help with household chores?
- Are you able to prepare healthy meals on your own?
- Do you have the financial resources to age in place?
- Are you able to re-

member to take your meds as required?

The NIA report also suggests that you "Be prepared for a medical emergency: If you were to suddenly become sick and unable to speak for yourself, you probably would want someone who knows you well to decide on your medical care. To make sure this happens, think about giving someone you trust permission to discuss your health care with your doctor and make necessary decisions. Learn about health care advance directives. Talk with your doctor about whether you should get a medical alert ID bracelet or necklace."

According to AMAC's Hafer, once you pass muster and become a candidate for aging in place, it's a good idea to take a tour of "your place" to make sure it's safe. He suggests making a room by room assessment as recommended by the AgingCare website to ensure that your home environment supports your lifestyle now and in the future.
