Vicky Umodu of San Bernardino, CA found the living room furniture she needed for her new home on Craigslist and it didn't cost her a dime, according to the Association of Mature American Citizens [AMAC]. Instead of quietly keeping the money, she called the previous owner who told her the furniture belonged to a deceased relative and that they, too, had discovered a bunch of cash filled envelopes in his home. The man, who remained anonymous, was so moved with Vickey's innate honesty, presented her with a \$2,000 reward for her good deed. Vicky, never for a moment, thought to take the money and keep quiet. "I knew I couldn't keep it. I knew I had to give it back." Love thy neighbor? 53% of Americans say they don't! DUNBAR SAGA #8 - Sister And Brother

Today, you will be reading about the 7th and 8th child of Lewis and Mary "Polly"

Powers Dunbar. You ask why? Because they both lived to adulthood but both died fairly young, thus not as much to say about them as someone who lived into their 90s as many of the Dunbars did!

Catherine was their 7th child and third daughter. She was born Nov 29, 1833 in Sugar Creek Township, Montgomery County, listed in the 1840 census as a female 5-10 years old and named in 1850 at age 17. Sadly, just the very next year she died before her 18th birthday (Jan 4, 1851) and she was buried in the same cemetery where her mother rested (she had passed in 1850) and

her father would in 25 years, at Union Cemetery at Clarks Hill in Tippecanoe County. (thanks to the Dunbar Family History by Andrey Schroeder).

Elias, her brother the 5th son, 8th child of Lewis and Polly was also born in Sugar Creek Township Aug 27, 1835 and is in both census records in his father's household and on his own accord as a married man in the 1860 census. He married a cousin of his mother's, Esther Bowers daughter of Abner Bowers and Charlotte Hoffman on April 3, in 1856 the ceremony performed by Rev. John P.

Indiana Attorney General Todd Rokita encourages Hoosiers to avoid scams by being mindful as they prepare for out-of-town summer vacations. To ensure your time away is as safe as possible, use caution to avoid crafty scammers.

"When planning your vacation this summer, remember anyone can be the target of a scam," Rokita said. "Often, when a deal seems too good to be true, it is. Be on the lookout for heavily discounted amusement park tickets, condos, and hotel rentals."

Here's a list of tips to avoid common vacation scams:

• Avoid high-pressure sales pitches before you book a trip.

• Be extra cautious when booking through an unfamiliar company. Check the Better Business Bureau ratings and research the name online to see if there are any allegations of scams.

• Read the fine print in the contract before you sign it. It will tell you about the conditions under which the operator can change or cancel the trip and the rules and penalties for cancellation.

• Pay by credit card. It gives you more protection than cash or checks.

• Use good judgment when sharing about your trip on social media. Consider changing your online privacy settings while on your trip.

• Lock your valuables, including personal information, in your trunk or hotel safe.

Of Bill To Help Americans In Saving For The Future U.S. Senators Todd

Young (R-Ind.) and Cory Booker (D-N.J.) applauded the passage of their Emergency Savings Act by the U.S. Senate Health, Education, Labor & Pensions (HELP) Committee on Tuesday, as part of S. 4353, Retirement Improvement and Savings Enhancement to Supplement Healthy Investments for the Nest Egg (RISE & SHINE) Act. The bipartisan bill was introduced last month to help Americans save for unexpected

expenses without having to tap into their retirement accounts.

"This action by the **HELP** Committee puts us one step closer to helping Americans better save for emergencies and preserve their retirement savings. The Emergency Savings Act enjoys support from across the retirement industry and political spectrum. It is a commonsense solution to an unfortunately too-common problem: Americans who find themselves without sufficient savings to cover unexpected emergencies," said Senators Young and Booker.

According to a report by the Federal Reserve, almost half of Americans would struggle to cover an unexpected \$400 expense. A recent study found that, in the past year, almost 60 percent of retirement account participants who lack emergency savings tapped into their long-term retirement savings, compared to only nine percent of those who had at least a month of emergency savings on

hand.

The Emergency Savings Act would facilitate convenient and affordable access to workplace emergency savings accounts, improving financial security and reducing retirement savings leakage. The bill builds upon work by Senators Young and Booker to develop this concept over the last several years, including the Strengthening Financial Security Through Short-Term Savings Accounts Act of 2021.

States Take On Transgender Extremism

Senators Young, Booker Applaud Committee Passage

Indiana Attorney General Todd Rokita and 25 other state attorneys general are calling on President Joe Biden to withdraw the recent U.S. Department of Agriculture's Guidance, which erodes the principles of Title IX by implementing new, expansive sex discrimination laws for schools that receive nutritional assistance from the federal government.

This administration has gone too far by forcing sexuality and transgender extremism into every part of our daily lives," Rokita said. "The new guidelines totally distort and dissolve the progress of women's rights in our country. Instead of ensuring the current law, Title IX, is upheld, President Biden insists

on catering to woke elites and ignoring the true problems Hoosiers and all Americans are coping with today."

Title IX was passed 50 years ago to ensure equal opportunities for women, but it is now being twisted to include the same protections for anyone who claims to be the opposite sex. This move comes as no surprise after Biden issued an executive order on his first day in office to force every federal agency to adopt a new set of standards when it comes to sexual identity. He defended his executive order by incorrectly citing the Bostock v. Clayton County case.

Earlier this month, the USDA's Food and Nutrition Service, announced it would implement the

new adaptations. The Biden administration's promise to make Title IX rule changes turned heads when details were revealed.

As a result of this the rule changes, any state, local agency, or program receiving federal funds through the Food and Nutrition Act and the Supplemental Nutritional Assistance Program administered by the USDA, must comply with the unlawful application of Bostock and Title IX, or lose federal funding.

The National School Lunch Program serves nearly 30 million schoolchildren each day, many of whom rely on it for both breakfast and lunch. Approximately 100,000 public and non-profit private schools and residential childcare institutions receive federal funding to provide subsidized, free, or reduced-price meals for qualifying children.

Expanding the concept of "discrimination on the basis of sex" to include gender identity and sexual orientation is harmful to Indiana schools and schools across the country

Rokita argues the new guidance is unlawful because it was issued without providing states the opportunity to respond as required by the Administrative Procedure Act. Further, it misapplies the Supreme Court's holding in Bostock and forces regulatory measures on state agencies and operators receiving federal financial assistance from the USDA.



BBB Tip: What You Should Know About Payday Loan Ads On Social Media

If you've ever needed extra cash to tide you over to your next paycheck, you understand the appeal of a payday loan. Now, video ads on places like Tiktok are promoting small, short-term loans to a new, young audience – and making them seem cheap and easy. However, just because it looks simple, doesn't mean it is. Predatory payday lenders are using the platform to make dishonest claims promising instant cash with no credit checks, late fees, or interest rates.

Many times, the advertisers are getting around the rules of the platform. TikTok and Meta have rules restricting ads for short term/payday loans, but some have found their way through.

Here's what you should know before taking out a payday loan from a social media ad.

Understanding payday loans featured on social media ads

• Apps might not call

it an "interest rate" but that's what it is. Many of the lenders that advertise on TikTok try to skirt regulations by creating new names for their service. By calling their interest rates a "tip" or a "fee," lenders hope you won't notice just how much interest you'll actually pay. Keep in mind, responsible lenders will always be willing to disclose the APR on their loans.

• Payday loans are costly. A two-week payday loan with a \$15 fee to borrow \$100 translates to an annual percentage rate (APR) of almost 400 percent, according to the Consumer Financial Protection Bureau. That's a huge jump from even a high interest rate credit card, which have rates of about 30 percent.

• Just because it's easy, doesn't make a payday loan a good idea. If you are young or have no access to other types of credit, you are an ideal target for a payday lender. Less-than-scrupulous lenders promote the fact that you don't need a credit check or any paperwork to get a loan. However, that ease can come at a high cost. Before you pursue a payday loan, spend some time shopping around for other options.

• Not all social media ads are truthful. Payday lenders seen on TikTok may promise you instant cash. But if it sounds too good to be true, it probably is. Many companies like these have faced scrutiny for deceptive lending practices, and some may simply be after access to your bank account. Don't believe everything you see on social media ads without doing further research.

• Be sure you can repay the loan. With such high interest rates, many people find themselves stuck in a debt cycle. In addition, payday loans can ruin your credit if you



find yourself unable to pay back what you owe. Better alternatives to payday loans

• Develop a budget with an emergency fund. Create a budget so you know how much money you have coming in and how much you need to pay your bills. This will help you avoid needing a loan in the first place. Then, set aside some cash each month to build up an emergency fund. Then, you will be covered even if an unexpected expense or an emergency comes up.

• Get credit counseling. If you find yourself unable to pay your bills or if you are caught in a debt cycle due to a high interest loan, get credit counseling. The U.S. Department of Justice has a list of agencies for people looking for debt reduction assistance. Also, check out BBB's tip on credit counseling for more resources.

• Shop around if you

need a loan. Compare interest rates, charges, and late fees by reading the fine print before you choose a lender. Pay close attention to both interest rates and loan rollover fees. Credit unions are a good place to take out a small loan with reasonable interest rates. Even credit card cash advances, which usually have interest rates in the double digits, likely have lower interest rates than what a payday lender will offer you. See tips on choosing a bank or credit union.

• Contact creditors if you can't pay on time. If you realize you won't be able to make a payment on time, don't panic. Contact the creditor directly. Many creditors will be willing to work with you to come up with a payment plan that you can afford.

Some Tax Considerations For People Who Are Separating Or Divorcing

When people go through a legal separation or divorce, the change in their relationship status also affects their tax situation. The IRS considers a couple married for filing purposes until they get a final decree of divorce or separate maintenance.

Update withholding

When someone becomes divorced or separated, they usually need to file a new Form W-4 with their employer to claim the proper withholding. If they receive alimony, they may have to make estimated tax payments. The Tax Withholding Estimator tool on IRS.gov can help people figure out if they're withholding the correct amount.

Understand the tax treatment of alimony and separate maintenance Amounts paid to a

Amounts paid to a spouse or a former spouse under a divorce decree, a separate maintenance decree, or a written the modification expressly states the repeal of the deduction for alimony payments applies to the modification. Alimony and separate maintenance payments received under such an agreement are not included in the income the recipient spouse.

Determine who will claim a dependent child if filing separate returns

Generally, the parent with custody of a child can claim that child on their tax return. If parents split custody fifty-fifty and aren't filing a joint return, they'll have to decide which parent gets to claim the child. There are tie-breaker rules if the parents can't agree. Child support payments aren't deductible by the payer and aren't taxable to the payee.

Report property transfers, if needed

Usually, there is no recognized gain or loss on the transfer of property between spouses, or between former spouses if the transfer is because of a divorce. People may have to report the transaction on a gift tax return. Consider filing status Divorcing couples who are still married as of the end of the year are treated as married for the year and must determine their filing status. The What Is My Filing Status tool on IRS.gov can help people figure out what status makes sense for their situation.

Here the statuses separating or recently divorced people should consider:

Married filing jointly. On a joint return, married people report their combined income and deduct their combined allowable expenses. For many couples, filing jointly results in a lower tax than filing separately.

Married filing separately. If spouses file separate tax returns, they each report only their own income, deductions, and credits on their individual return. Each spouse is responsible only for the tax due on their own return. People should consider whether filing separately or jointly is better for them.

Head of household. Some separated people may be eligible to file as head of household if all of these apply:

Their spouse didn't live in their home for the last

The inaugural group of students to receive the Navarro Family Scholarship for the 2022-23 academic year are Connor Grimes (French Lick, Indiana), Adonis House (Anderson, Indiana), Maximus Rosa (Ridgewood, New York), Brandon Salas (Indianapolis, Indiana), Benjamin Weaver (Houston, Texas), and Brenton Wood (Frankfort, Indiana).

The group represents three states, four of the six were team captains, and one has participated in a three-week study abroad program in Portugal studying aquatic ecosystems. Collectively, these scholarship recipients have identified academic areas of interest in fields including biology, business, pre-law, premed, and psychology.

Navarro served as head coach of the Wabash football team from 1974-77, amassing a 26-17 (.605) record in those four seasons. He guided the 1976 Little Giants to a 7-3 record, the program's first winning season in 11 years. A year later, his charges posted an 11-2 mark, earned the first NCAA Playoff berth in school history, and advanced to the Amos Alonzo Stagg Bowl, the NCAA Division III national championship game. For his efforts,

Navarro earned the Eastman Kodak-American Football Coaches Association College Division Coach-of-the-Year Award in 1977. In September 2021, the playing field at the newly dedicated Little Giant Stadium was named "Frank Navarro Field" in his honor. Covering 22 seasons as a head coach at four institutions, Navarro posted a career record of 99-99-6 (.500). Frank and Jill Navarro have eight children, 22

grandchildren, and three great grandchildren. He entered the real estate business with his sons after retiring from coaching and passed away in May 2021 at the age of 91.

Wabash has a historic commitment to recruiting and graduating young men of great promise and high financial need. The College also has a legacy of graduating students who are the first in their family to graduate from college and for whom - without generous scholarships and financial aid – could have never attended a four-year college or university. While the scholarship

celebrates the connection

of the Navarro family to Crawfordsville, the College will cast a wide and strategic net to identify promising Navarro Scholars across the country.

Wabash offers 27 majors and 31 minors to nearly 900 students from diverse economic, social, and cultural backgrounds. Nineteen percent of Wabash students self-identify as domestic students of color; 29% identify as first-generation students; and 99% of all students receive financial aid, with 27% qualifying for federal Pell Grants.

Livengood. Elias' father sent a note to "Mr. Clerk of Montgomery County Indiana – pleas let the bearer have Marriage License for my son Elias Dunbar and oblige me Lewis Dunbar – Witness present: Silas Dunbar." That would be a nifty piece of family history with both Lewis and Silas' signatures (cdpl).

Sadly, Elias died five years later of typhoid. His FindAGrave entry (photo by srenie - Union Cemetery, Clarks Hill) says he was a Civil War soldier (although a descendant's wife is working on getting it taken off), his death came before the Civil War on 12 Feb 1861. I found no records he was in any unit, his wife did not get a widow's pension, so that one is hard for me to swallow. He is of course, buried in Union Cemetery. Esther herself would pass just five years after he did, having been married to William Chenoweth but a year, and their only child just a few months old. On Nov 17th, 1862 the Dunbar children's guardianship went through, Esther's father, Abner giving surety and Abonijah Bowers, her brother becoming their guardian. Imagine this took such awhile as she was just living with her children with her father and finally took it to court. Or, perhaps Elias died in 1862 (making it a possibility to have been in the war) vs. 1861 but since nothing other than a note



on his entry on FindA-Grave says he was in the war, thinking not. Sadly, the daughters, Mary Ellen and Charlotte would be gone in a very short time. Elias and Esther's son, Elias Peter was born two days after his father's death. At age 28, he married Emma Coe Parker in Tippecanoe County and they had six sons and two daughters, all to grow to adulthood as far as I know. Elias Peter and his wife celebrated their 50th anniversary and beyond. He passed at age 80 (7 May 1941) and is buried in Plainview Cemetery, Emma passing at age 90 in 1956. Willard Parker Dunbar, son of Elias Peter distinguished himself in many ways as a veteran of WWI (oddly, he requested a religious exemption as a member of the Church of the Brethren) as a teacher, coach, boxing champion and expert rifleman while teaching at the Culver Military Academy. He married Irma Dykes a

Sugar Creeker Nov 29, 1926 while he taught at Culver (mathematics, as well as the assistant coach in rifle marksmanship having represented Culver on the marksman team) and Irma, a graduate of Butler was in several plays and had a dramatic studio in Indianapolis. The Academy had a lovely formal dinner for the couple after a small wedding. He also represented Indiana in a Civilian Rifle Team and the US Army Reserve Corps team. At a point, he was assistant coach on the US International Champion rifle and pistol team. In 1931, he returned here and took up farming, chiefly raising cattle. Many visitors would come to see his strategies. He and Irma were parents of three sons (Willard, Samuel, Peter) and a daughter (Jean). Joseph Elias was born in MoCo and died in Colfax, Clinton County at age 85. He taught locally then went on to become a University of Minnesota professor from where he retired and was a life member of the American Legion. He may have had one son, Wilbur.

A 45-year farmer in Boone and Montgomery, Austin Walton Dunbar (born on Halloween 1894 died the day after Christmas 1975) was a WWI veteran, member of the Church of the Brethren. married Catherine Everhart (whom he had met at a church social) and they parented one son, John Robert and four daughters (Caroline, Joan, Mary and Nancy). Austin received his teacher's license but taught briefly. Mainly he loved his free time walking his fields in Boone and Montgomery County searching for artifacts, tallying quite a collection of nice pieces. Thanks so much to Austin's grandson, Dan and his wife Dana for guiding me along on the Dunbar Saga. Harvey Nelson Dunbar was also born at Bowers (21 Nov 1897) and died fairly young for a Dunbar (age 59 on 27 March 1957 in Lafayette), buried of course at Plainview. He and wife Geneva Robinson had at least five children (Bettie (b/d 1921), John (a WWII veteran and operated the Phillips 66 station in Clarks Hill, as well as working at International Harvester, John Deere and the Tipp Co Highway), Donald (b/d 1931), Marilyn and lastly, Nelson who passed in the 2020 covid epidemic

- buried Plainview.

Roscoe Arthur also did not live to be old for a Dunbar, born at Bowers 2 May 1899 and dying 26 August 1956, buried at Annapolis, Maryland in Hillcrest Memorial Gardens. He married a Darlington gal, Helen McGuire Custer 25 June 1924. He was a school teacher but not sure why they went to Maryland. They had at least one child, James Ralph (Jim, a Colonel in the Air Force but buried at the US Naval Academy Cemetery in Annapolis where he attended school serving as a pilot in

Beatrice. Mae graduated from North Manchester College and taught high school in Wisconsin for quite some time. She was active in Eastern Star and Coschocton Women's Club. Leslie farmed, then managed a Farm Bureau. They were both active members of the Brethren Church and were married in Montgomery County 12 Oct 1915, spending the majority of married life in Ohio.

Perhaps sister Lillian Esther followed her brother to West Virginia? At any rate, she was born in Colfax and died in Charleson WV at age 77 on 13 Nov 1968. She married Manassah Judy in 1912. He was a farmer, principal of a high school, insurance agent and served several years as Grant County, WV clerk of the court. They had no children and no clue how they'd have met Sadly, these two Dunbars didn't live a lengthy life as so many of the family did. Catherine died so young and Elias living not a great deal longer, but both had their blessed places in the family of Lewis and Polly, as well as continuing the Saga.

Theodore Bowers Dunbar (born appropriately at Bowers 2 Feb 1902) lived for many years in Charleston, West Virginia but passed 23 Aug 1977 in San Jose, California and is buried in Grandview Cemetery in Southmont, Cambria County, Pennsylvania. He taught high school and was a Farm Bureau insurance agent.

The oldest daughter of Elias Peter and Emma Coe (Parker) Dunbar was Mae Elizabeth born in Bowers (5th day of 1890) and passed away at her long-time home in Coshocton County, Ohio. She married Leslie V. Halladay who at least for a few years was in our area. They produced one daughter,
