More Than \$5.2 Million Was Awarded Locally

Local communities will receive more than \$5.2 million to improve roads and bridges through the Community Crossings Matching Grant Program (CCMG).

The CCMG, established by the Indiana General Assembly in 2016, aims to advance community infrastructure projects, strengthen local transportation networks and improve Indiana's roads and bridges. Since its enactment, the program has awarded more than \$1.1 billion in state-matching funds for local construction projects.

Indiana is an infrastructure leader thanks to initiatives like the CCMG. Our local government leaders deserve a lot of credit for obtaining this funding, and the state has a duty to support them, especially

in our rural communities. Through the program, the Indiana Department of Transportation matches up to \$1 million annually when localities invest in road and bridge repairs. Counties with populations fewer than 50,000 and cities and towns with populations fewer than 10,000 receive a 75%/25% match, while counties with populations greater than 50,000 and cities and towns with populations greater than 10,000 receive a 50%/50% match.

Young Votes To Support Troops, Modernize Response To Global Threats

Thursday, U.S. Senator Todd Young (R-Ind.) voted in favor of the Fiscal Year 2023 National Defense Authorization Act (NDAA). The bill passed the Senate 83-11 and will now head to the President's desk to be signed into law.

The NDAA is the annual legislative vehicle that authorizes all programs and spending for the Department of Defense (DoD). Young, a U.S. Naval Academy graduate and Marine who serves on the U.S. Senate Foreign Relations Committee, worked on provisions of the legislation that will modernize our military and respond to threats from the Chinese Communist Party (CCP).

"At a time of increasing threats and heightened national security challenges, this critical bill takes big steps in putting the United States on a better trajectory to out-compete the Chinese Communist Party, invest in a 21st Century Arsenal of Democracy, and provide our brave men and women in uniform with the support they

"Xi Jinping and the Chinese Communist Party are telegraphing their regional and global ambitions, and this bill will help us better deter and defend against the CCP's increasingly aggressive behavior, including through Senate Foreign **Relations Committee** provisions incorporated in the bill to reinforce the security of Taiwan.

"Finally, I am glad that the bill contains a consensus, bipartisan version of the BURMA Act, which will support the Burmese people in their time of need, push the Administration to impose new sanctions on those committing horrific human rights abuses, and ensure that the whole of the U.S. government is working together to

restore democracy in Burma. I am grateful for the continued work and advocacy of Indiana's Burmese community on this important issue," said Senator Young.

As passed, the NDAA provides our troops a 4.6 percent pay increase and proposes a 12 percent increase over last year's military budget, which will help support our military during the worst inflation in decades.

The bill also makes critical investments in our nation's industrial base to ensure that our military is equipped for future fights and to backfill the supply of munitions that have been provided to Ukraine to defend against Russia's invasion.

Senator Young secured a number of key priorities in the legislation.

Senator Young's provisions in the NDAA:

The retirement of Air Force A-10 fighter jets will clear the way for the 122nd Fighter Wing in Fort Wayne to transition to the F-16 fighter, better equipping it for future fights and ensuring the Wing is well-positioned for future decisions

regarding the F-35 Joint Strike Fighter.

Bipartisan Burma provisions will support the efforts of the National Unity Government to reform Burma's constitution, support the restoration of the legitimate government, and hold the Burmese military and its international backers accountable for their crimes.

Hypersonic weapon research reporting requirements build upon a proposal submitted by Senator Young to the Armed Services Committee that will ensure that academic and private-sector partners are not overlooked in the DOD's efforts to field an effective hypersonic weapon. Indiana is a national leader in this research, through entities like Purdue University, the University of Notre Dame, and Rolls-Royce.

The Great Lakes Winter Commerce Act will ensure the Coast Guard is adequately tracking icy conditions on the Great Lakes, working with Great Lakes stakeholders, and resourcing the acquisition of new, capable icebreakers.

Indiana Farm Bureau President Reflects On A **Challenging Year; Cautiously Looks To 2023**

Each year at the Indiana Farm Bureau State Convention, the organization's president reflects on the past year with members from across the state. INFB President Randy Kron shared his thoughts in his annual address last night, where he and host Gerry Dick, veteran broadcaster and host of Inside Indiana Business, had a frank conversation about the ag economy and the challenges that may await farmers in 2023.

Kron, who is entering his eighth year as INFB president, discussed some of the most important issues facing agriculture today, starting with the ag economy and what a challenging year 2022 turned out to be due to universal price increases for inputs, including seed and herbicides, but especially fertilizer and fuel.

"It was a challenging planting season for so many reasons," explained Kron. "Fertilizer and fuel are two of the largest line items when it comes to row crop farming. It cost more to put a crop in the ground this year than most of us have seen in our lifetimes.

"And grain farmers aren't the only ones facing challenges. Disease pressure, market volatility, rising feed costs and



inflation are on the minds of the livestock and poultry sectors too."

Kron provided insight into some of the factors causing input price increases. The first being the supply chain. Kron clarified there have been a number of reasons for an impacted supply chain, including lingering effects of COVID-19, last year's Hurricane Ida that damaged fertilizer plants on the Gulf Coast and the war in Ukraine. He also noted the lack of supplies affected farmers' ability to get equipment and parts in a timely manner, which added to the challenges of this year.

Despite these difficulties, Kron said farmers are still eternal optimists.

"I've farmed for 39 years, and one thing has remained the same over all those years - I always think next year will be better," said Kron. "I

think every farmer thinks next year will be better – we have to. I guess it comes down to our love for the land."

Kron did note that this year's harvest turned out better than expected for most Indiana farmers. Even though supply was tight, demand was high, so farmers have received good prices for their crops. Therefore, most farmers are remaining profitable this year because margins are good, despite all the issues faced during planting

Kron was cautious in his outlook for 2023. "The supply chain will still be impacted, meaning input prices will remain high, but crop prices will likely come down, causing margins to be tight."

When asked about national issues in 2023, Kron stated that Farm Bureau will have an

important job in the farm bill debate - a piece of national legislation that governs many agricultural and food programs. Specifically, Kron mentioned how critical the legislation is for farmers in terms of crop insurance, but also the importance the farm bill has on nutrition. Seventy-five to eighty percent of the farm bill is centered on nutrition, providing significant benefits to low-income families through food programs, like the SNAP initiative.

Kron closed by thanking staff, volunteers, members and his family for their support throughout the year.

"Even when things are at their toughest, Hoosier farmers rise to the challenge. And we will do that in the coming year," said Kron. "Farmers aren't afraid of hard work.'

The 2022 INFB State Convention continues through Saturday, Dec. 17 and includes a brand-new trade show, AgriConnect, featuring agribusinesses, breakout sessions covering topics top-of-mind to farmers and keynote speakers.

The 2023 INFB State Convention will be held Dec. 14-16 in Fort Wayne, Ind.

IWU Acquires Eleven Fifty Academy To Expand Tech Education Capabilities

Indiana Wesleyan University (IWU) has received board of trustee approval to acquire the key assets of the Eleven Fifty Academy in a deal that will allow the program to continue providing Hoosiers a quick, proven way to ramp up their technical skills for future careers in the tech sector.

"The Executive Committee of the Board of Trustees, acting on behalf of the entire board, enthusiastically and unanimously approved the acquisition of key assets from Eleven Fifty Academy at today's board meeting," said Carl Shepherd, IWU Board of Trustees Chairman.

"The University has a long and successful history of innovation in Higher Education. I am excited to watch as the administration works with local and state officials and the private sector to leverage the Academy to address the workforce needs today and in the future."

With the acquisition complete, Indiana Wesleyan University now shifts its focus on hiring a managing director to



oversee the nonprofit organization that will operate as an affiliate organization of IWU.

'We believe strongly in developing programs that align with our commitment to academic excellence," said Dr. Jon S. Kulaga, President of

"The Eleven Fifty Academy acquisition of key assets supports our online and regional center strategy to provide lifelong learners opportunities to further their education and create a better life for themselves, their families, and our community.'

"We strongly believe the Academy is a valuable resource in assisting

Indiana Gov. Eric Holcomb and his administration's focus on addressing the workforce needs throughout the state of Indiana," Kulaga said.

Former Eleven Fifty Founder Scott Jones will not have a role with the new organization. IWU has engaged John Qualls, a long-time tech business entrepreneur and a former executive at Eleven Fifty, to lead the transition effort during this interim period.

"It is important to acknowledge Scott Jones for his tireless efforts to create an organization that can move the needle for re-skilling a workforce," said Dr. Eileen Hulme, Chancellor of

IWU-National & Global. "We thank him for his

commitment to improving the lives of Hoosiers. We understand this program must continue to give students an affordable way to rapidly gain the skills needed in today's tech workforce. IWU plans to build on this while also enhancing its reach by using our network and existing infrastructure to connect to those who seek to further their education.'

IWU has acquired the

following key assets as part of the deal: Eleven Fifty Academy's curriculum, trademarks, trade names, domain names, and social media accounts. It also assumes responsibility for the continued education of the approximately 65 students scheduled to complete their training in March 2023. IWU hopes to build relationships with past alums of the program and offer both current students and alums of the Academy an opportunity to continue their educational journey through IWU's various programs. IWU is not assuming any responsibility for its debt.

State Keeps Tik **Tok Pressure On** Apple, Google



Less than a week after launching two separate lawsuits against TikTok, Indiana Attorney General Todd Rokita now is calling on Apple and Google to change their age ratings for the app when making it available to consumers.

"Sexual content, profanity and drug references run rampant in TikTok videos," Rokita said. "This kind of material threatens the mental and physical health of young Hoosiers, and not only TikTok but also vendors must make it clear to families that TikTok is wholly inappropriate for

Specifically, Indiana is demanding that Apple update the TikTok rating from "12+" to "17+"

in its App Store and that Google update the Tik-Tok rating from "Teen" to "Mature" in the Google Play Store.

The current ratings are misleading and deceptive to consumers, as explained in two multistate letters — one sent to Apple and the other to Google.

On Dec. 7, Rokita filed two lawsuits against TikTok.

One lawsuit alleges that TikTok lures children onto the platform through a variety of misleading representations.

The other asserts that TikTok — which is owned by a Chinese company — has reams of highly sensitive data and personal information about Indiana consumers and has deceived those consumers to believe that this information is protected from the Chinese government and Communist Party.

"We are determined to hold this company accountable," Rokita said. "And that goes for its enablers as well. We're ready to pursue further legal actions if necessary."





clarity, federal employees who retire under the newer Federal Employee Retirement System (FERS) are not affected by WEP because they contribute to Social Security.

The formula for computing Social Security when WEP applies is rather complicated and depends on the number of years you contributed to Social Security from substantial earnings in the private sector. With 20 or fewer years contributing to SS you incur the maximum WEP penalty for your "eligibility year" (the year you turned 62), but with more than 20 years contributing to Social Security the WEP reduction is mitigated, and with 30

or more years contributing to SS, WEP no longer applies.

If you were receiving your CSRS pension when you claimed Social Security, your WEP-reduced SS benefit was computed at that time and has continued. But if you had additional years working and contributing to Social Security after you first claimed, it's possible that you now have more than 20 years contributing, in which case you may be entitled to a smaller WEP reduction and thus a higher Social Security benefit. The only way to find out if you're now entitled to a higher benefit due to additional years contributing is to call Social Security,

either at your local office or at the national number 1 (800) 772-1213 and ask them to review your current benefit under WEP. If you now have more years contributing to Social Security than you had when you first claimed, you may be entitled to a benefit increase.

Before calling SS, you may wish to first review your lifetime earnings record on file at Social Security and determine how many years of contributions from substantial SS earnings you actually have. You can get a copy of your lifetime SS earnings record from Social Security, most easily from your personal online "my Social Security" account.

If you don't yet have an online account set up, you can easily do so at ssa. gov/myaccount. Then, you can review your lifetime SS-earnings against the chart at the following link which shows what your earnings must have been each year to count under WEP: ssa.gov/pubs/ EN-05-10045.pdf.

So, to recap: if you continued to work after starting your WEP-reduced Social Security benefits, you may be entitled to a smaller WEP reduction and thus a higher Social Security benefit now, but you will need to contact Social Security to evaluate your current status (and, if appropriate, increase your Social Security benefit).

people age 75 and older are treated, according to a scientific statement from the American Heart Association, published in its flagship, peer-reviewed journal "Circulation.'

The statement, "Management of acute coronary syndrome (ACS) in the older adult population," highlights evidence to help clinicians better care for older patients. According to the statement, 30-40% of people hospitalized with ACS, which includes heart attack and unstable angina (heart-related chest pain),

are age 75 or older. "Older patients have more pronounced anatomical changes and more severe functional impairment, and they are more likely to have additional health conditions not related to heart disease," said Abdulla A. Damluji, M.D., Ph.D., FAHA, chair of the scientific statement writing committee, director of the Inova Center of Outcomes Research, and an associate professor of medicine at Johns Hopkins School of Medicine. "These include frailty, other chronic disorders (treated with multiple medications), physical dysfunction, cognitive decline or urinary incon-

tinence."

Normal Aging and **Age-Related Changes** in the Heart and Blood

Vessels: Cardiovascular changes that occur with normal aging make ACS more likely and may make diagnosing and treating it more complex. These changes include large arteries becoming stiffer, the heart working harder but pumping less effectively, blood vessels becoming less flexible and less able to respond to changes in the heart's oxygen needs and an increased tendency to form blood clots. Sensory decline due to aging may alter hearing, vision and pain sensations. Kidney function also declines with age, with more than 1/3 of people ages 65 and older having chronic

kidney disease. **Multiple Medical** Conditions and Medica-

As people age, they are often diagnosed with health conditions that may be worsened by ACS or complicate existing ACS. As these chronic conditions are treated, medications prescribed may result in unwanted interactions or medications that treat one condition may worsen another.

"Geriatric syndromes and the complexities of their care may undermine the effectiveness of treatments for ACS, as well as the resiliency of older adults to survive and recover," Damluji said. "A detailed review of all medications - including supplements and overthe-counter medicines - is essential, ideally in consultation with a pharmacist who has geriatric expertise."

Steps for Heart Attack Care and Follow-Up for Older

- Call 911 if you notice someone experiencing heart attack warning signs. These include chest discomfort, discomfort in other areas of the upper body (one or both arms, back, neck, jaw or stomach), shortness of breath or other symptoms such as a cold sweat, nausea or lightheaded-
- Consider treatment needs for co-existing conditions. An individualized, patient-centered approach is best for older adults.
- Get input from multiple specialists, including a pharmacist, to manage care and medications.
- People with cognitive difficulties and limited mobility may

benefit from a simplified medication schedule, with fewer doses per day and 90-day supplies of medications so fewer refills are necessary.

- The goals of care for older people with ACS should extend beyond clinical outcomes and focus on quality of life and the ability to live independently.
- Do-not-resuscitate orders should be discussed before any surgery or procedure.
