## **THREE THINGS** You Should Know:

McCormick's Creek State Park, which was severely damaged by the recent tornado, is open for limited use. The park's Canyon Inn restaurant is fully open but many park trails remain closed, and the campground will be closed through Oct. 1. Individuals with campground reservations are being contacted directly and given full refunds, and no new reservations for camping at McCormick's Creek will be accepted for arrival dates through the end of 2023. # **Boomer Bits Ask Rusty - Retired Public Servant Feels Government Pension Offset is "Unjust"**

Dear Rusty: I'm a retired firefighter and live in Ohio. I earned Social Security from my side employment, but the Windfall Elimination Provision (WEP) hit my Social Security verv hard. My wife worked in the school system and earned a state "SERS" pension. I understand the WEP offset and that doesn't bother me as much as the fact that my wife doesn't get my Social Security benefits when I die - her state pension is above the monthly limit for her to receive my Social Security. I earned that benefit by working extra jobs and being away from my family, and it seems unjust that my benefits expire with me. Thanks for letting me vent. Signed: Retired Public Servant

Dear Retired Public Servant: The provision you deem as "unjust" isn't the Windfall Elimination Provision (WEP) which affects SS retirement benefits for those who also have a "non-covered" pension (a pension earned without contributing to Social Security); rather it is the Government Pension Offset (GPO) which also affects those who have a pension earned without contributing to Social Security. Though I know it is no consolation, your frustration about the Government Pension Offset (GPO) is shared by nearly a mil-

survivor benefits are paid to all beneficiaries. I'm certainly not defending it, but I've researched why the GPO was enacted decades ago.

ASK Rusty

Historically, ever since spousal and survivor benefits became part of Social Security's benefit structure in the late 1930s, if a spouse also has their own personally earned SS benefit, any spousal/ survivor benefit they also became entitled to was offset by their personally earned SS retirement amount. The prevailing opinion in the 1983 Congress was that because regular spousal and survivor benefits are normally offset by the spouse's own earned SS benefit, it was unfair that a spouse who had a "non-covered pension" didn't incur the same offset as those who had no such non-covered pension. Thus, GPO was enacted in 1983 to "equalize" how spousal and survivor benefits were paid. It is the GPO which will affect your wife's benefit as your surviving spouse

perspective, if your wife had, instead, worked outside of the OH school system and was entitled to a full Social Security benefit based on her own earnings from which she contributed to SS, any survivor benefit she might become entitled to from you would still be offset by her personally earned SS retirement benefit. If her own SS retirement benefit was more than her entitlement as your widow, she would get no additional amount as your surviving spouse. Or if her own SS retirement benefit was smaller than yours, her survivor benefit would still be offset by her own benefit (her benefit would be paid first and only a supplement added to bring her payment to the higher amount she was entitled to as your widow). The purpose of the Government Pension Offset is to equalize how spousal, or survivor benefits are paid to those with, and to those without, a non-covered pension. Indeed, because the GPO only offsets the

# Newswoman Tammy Bruce **Shares What Can Change** The Future Of America

Fox News reporter Tammy Bruce says that in the days before the Internet and social media, politicians were used to being able to define reality based on what they told us. Now, however, there are cameras everywhere, she added, and they allow us to see for ourselves what really happens when events such as what happened on January 6, 2021, in Washington DC occur. As Tammy put it during a recent AMAC Better For America podcast interview, "Things got out of hand."

She told BFA host Rebecca Weber, CEO of the Association of Mature American Citizens, that "some people deserved to go to jail." But, she noted, footage of surveillance cameras reveals that no, it was hardly an event that could be compared with Pearl Harbor, as Vice President Kamala Harris described

it. Nor was it akin to World War II or the Holocaust, as others portrayed it. She said that the surveillance video her Fox News colleague Tucker Carlson obtained "reveals the absurdity of what is being said by Democrats who have relied on censorship throughout the last several years of social media so that they can try to control reality."

Tammy published an article recently on AMAC's website focused on a riot that provided a surprising reminder of how nefarious and disgusting corruption in the FBI really is. It took place in Atlanta, GA. She wrote, "35 people were detained and 23 people were arrested on domestic terrorism for a violent attack on the building site of a police training center. The police described a violent scene which unfolded in classic Antifa





#### Proclamation Public Safety Telecommunicators Week: April 9 to 15, 2023

National Public Safety Telecommunicators Week (NPSTW) is held annually during the second week of April to honor public safety telecommunicators for their commitment, service, and sacrifice.

NPSTW initially started in 1981 by Patricia AnderHot mix Paving utilizes funding from a Community Crossings Grant from the State. The roads that are selected based on the following criteria: does it complete the "loop" around Crawfordsville, does it enter/ exit the county? and is it classified as a major or minor road? This data is input in to a score sheet to help prioritize those roads.

#### Chip seal: Roads are chip sealed that have been cold mixed the prior year or it is needed for preservation.

Gravel road maintenance:

Covers when to grade and how roads are selected. The Department has 4 graders and it takes 5-6 weeks to complete an area depending on the weather. The Highway Department will not grade if moisture is abundant or an abundance is forecasted. The Highway Department determines gravel material to be applied by the following factors: gravel roads that connect major roadways, apparent traffic, # of homes, and if there are businesses on the roadway.

# Writer Urges Caution on Senate Bill 37

#### Dear Editor,

Living in a county with an interstate highway running through it is both a blessing and a curse. My county is blessed with Interstate 70, which offers relatively easy commuting into metro Indianapolis. However, drug trafficking is anecdotally greater here than in counties without interstate highways.

Indiana counties with interstate highways passing through should therefore take advantage of such highways in every way possible. One example would be the food & beverage tax. Any county that has an interstate highway passing through would be foolish to NOT have a food & beverage tax. With three exits along I-70, our county receives an additional 1% tax on purchases made in restaurants at each of its exits. This extra 1% also applies to restaurants elsewhere in the county, as enjoyed by residents. Henry County's food & beverage tax was initially allowed by the state legislature in 1987 to build the Indiana Basketball Hall of Fame. Other projects funded by the food & beverage tax include our Ivy Tech campus, the Arts Park Pavilion, Middletown Historic Society, Knightstown's iconic Hoosier Gym, and several railsto-trails projects, among others. The net effect has improved our county's quality of life and quality of place, as well as business generated by these tourist destinations. Senate Bill 37 is now up for consideration in the State House. If signed into law, SB37 will phase-out by 2045 all current food & beverage taxes across Indiana, "other than the stadium and convention building authority food and beverage tax and the historic hotels food and beverage tax." Translation: the Indiana Convention Center and Lucas Oil Stadium will continue to be subsidized by food and beverage taxes from Marion and its surrounding "doughnut" counties, as will the French Lick Springs Resort and West

Final Reading: An Ordinance Establishing Highway Department Policies for Road Maintenance and Snow Removal

Memo from the Highway Department:

The Highway Department Policies and Procedures were created to have a written policy of why and how the Highway Department maintains roads and conducts snow removal operations. The policy utilizes quantitative data to determine the roads that will receive maintenance.

#### Paving:

Cold mix and hot mix paving policy.

Cold mix paving: We use a score sheet that has data including function class, PASER Rating, Average daily traffic, Action Request, attractor, pot hole saturation, and hours of labor spent on the roadway. The data is put into the score sheet and the order of which we pave roads is determined by the score and that sets priority.

Culvert Replacement: Road projects are evaluated depending on the application. Culverts are always replaced on a road project applying hot mix. In a cold mix road project, if the culvert has 10 year or less life expectancy, the county will replace it. If it's not on a project road, then the criteria are: dangerous, man made changes to drainage, topography, and the amount of water volume.

#### Speed Limits:

The Highway Department will conduct a traffic study and input collected data into Federal Highway Administration website to calculate the limit. Road type and crash data are also tools to determine a correct speed limit posting.

#### Snow Removal:

Policy states that paved roads are a priority. If we have more than five inches of snow and or drifting the graders will be sent directly to gravel roads. During snow events normal start time is between 3am & 5 am. (This is subject to change). The Highway Department uses a 25% salt mixture with sand for roadways. Straight salt is used in housing additions. Shifts are usually 14 to 16 hours. If weather is severe enough, 2-4 snow plow drivers will stay on shift for as long as necessary.



for 12 years, I witnessed first-hand how Indiana's counties, especially rural counties, are being fiscally squeezed by Indianapolis. For example, the state particularly targets county health departments and county park departments, forcing them to raise user fees. As user fees can only be raised so much, county parks, for example, could benefit from a food & beverage tax. Henry County Memorial Park is a true gem, especially as compared with most other counties (not every Indiana county even has a county park). Our park hosts the Veterans Museum and Saddle Club, both of which benefit from the food & beverage tax - and generate tourist revenue.

Critics of the food & beverage tax blame mismanagement in one county, which never built a riverside convention center that was the basis for its 1989 implementation. However, in Henry County, the food & beverage tax committee that oversees the process, is a group of citizen volunteers appointed by the County Commissioners, County Council, New Castle Mayor, and New Castle City Council. # **Construction Sector Sheds 9,000 Jobs In March As Low Unemployment Rates And High Number Of Job Openings Indicate A Lack Of Workers, Not Demand**

Labor Shortages are Making it Harder for Firms to Replace Retiring Workers as Construction Officials Continue to Call for New Construction **Education and Training** Support and Immigration Reform Measures.

The construction sector shed 9,000 jobs in March, the first decrease since January 2022, even as the sector's unemployment rate fell and total number of job openings in the sector hit a near-record high, according to an analysis by the Associated General Contractors of America of new government data. Association officials said the industry was struggling to replace aging workers and pushed for new construction training and education support, as well as immigration reform measures to encourage more people into the industry.

"Despite a small dip in headcount, construction firms continued to post a

high level of job openings and raised pay more than other industries-two signs they still want to hire more workers," said Ken Simonson, the association's chief economist. "But the pool of unemployed, experienced jobseekers keeps shrinking for the construction sector."

Construction employment in March totaled 7.888,000, seasonally adjusted, a dip of 9,000 or 0.1 percent from the record high in February and the first decrease in 14 months. Nonresidential firms-comprising nonresidential building and specialty trade contractors along with heavy and civil engineering construction firms-shed a statistically insignificant 1,800 employees in March. Employment at residential building and specialty trade contractors slipped by 7,000 or 0.2 percent.

The unemployment rate

outdo Complete Outdoor Maintenance among jobseekers with construction experienced declined from 6.0 percent in March 2022 to 5.6percent, the second-lowest March rate in the 23-year history of the data. A separate government report released earlier this week reported that job openings in construction at the end of February totaled 384,000, just shy of the all-time high for February of 388,000.

Average hourly earnings for production and nonsupervisory employees in construction—covering most onsite craft workers as well as many office workers-jumped by 6.6 percent over the year to \$33.82 per hour. Construction firms in March provided a wage "premium" of nearly 19 percent compared to the average hourly earnings for all private-sector production employees.

Association officials said federal officials have

failed to boost investments in construction education and training even as they have boosted investments in a wide range of construction programs. They urged public officials at all levels to provide more support for construction programs in schools, apprenticeships, and other training programs. And they urged Congress and the Biden administration to allow more workers with construction skills to lawfully enter the country to work in the sector.

"Firms are struggling to fill high-paying construction positions while many schools continue to push students to go to college, amass student debt and hope for an office job," said Stephen E. Sandherr, the association's chief executive officer. "Exposing students and other future workers to construction will signal that it should







style: people wearing black clothing holding shields were throwing rocks, bricks, Molotov cocktails, and fireworks at property and building materials and police officers. Also typical of Antifa, 21 of the 23 arrested had come from out of state, as ABC News reported, 'Some from as far away as Utah, Colorado, Arizona, and New York. Two protesters charged are from other countries, one From France and another from Canada, according to police." Additionally, "one of the two locals who were arrested and charged with domestic terrorism was identified as Thomas Jurgens, a 'Staff attorney with the Southern Poverty Law Center (SPLC), the left-leaning anti-hate group, according to the State Bar of Georgia and his since-deleted LinkedIn page,' according to the New York Post."

During her BFA interview, Tammy noted that "it's not just the SPLC, but it's also the ACLU ... [at issue] is the question of where is the money

coming from? Clearly, it's a segment of extremist activists that are funding these liberal entities that [once] fought for freedom of speech and genuine civil rights. But now it's political extremism. Only two of [those arrested in Atlanta] were local. Everyone else came from out of state and in a few instances, from other countries. And that's what Antifa does. They import these people. These were not Atlantans rioting. These were people who move about as a team. And this is the kind of thing that the media really needs to make sure people know. During the George Floyd riots, two lawyers were arrested for throwing Molotov cocktails into a police vehicle. They were lawyers working at firms in New York City. They have been disbarred, thank goodness and they pled guilty to the charges. But then the Biden administration came in and reversed that and allowed them to plead guilty to lesser charges. So why would the Biden

administration intervene with two people who are lawyers who committed violence, who abused their licenses and their commitment to the law, making it easier for them to get lighter sentences, which they did?" It is almost as though, Tammy shared, "that these entities are working together to cause as much chaos and disruption as possible."

And besides the government's efforts to squash the truth, Tammy believes Americans can still save our country. To her, it's time the "National Republican Party and its leadership must step up." To her, "It's about states taking control locally where your voice is more heard more rapidly...and keeping control in that regard." And after seeing what DeSantis and other states have done in regard to issues like banning CRT and protecting your children, Tammy insists that "those must be templates for the federal government as well as for every other state in our union."

the more common early warning signs and symptoms may include shortness of breath, a cough that may bring up mucus or phlegm, chest tightness, fatigue and reoccurring lung infections. People may think these symptoms are because of aging, smoking or being out of shape and become less active to avoid experiencing them. These signs and symptoms shouldn't be ignored. Speak with your healthcare provider if you experience any of these symptoms and discuss any activities you are avoiding due to breathing difficulties.

•Risk Factors and Diagnosis

Anyone can develop COPD, but people aged 40 or older and those who smoke or used to smoke are at higher risk. Cigarette smoking is the leading cause of COPD, however 1 in 4 people with COPD never smoked cigarettes. Secondhand smoke, air pollution, workplace exposures to dust, fumes and chemicals, and a genetic condition called alpha-1 antitrypsin deficiency (AATD) are also causes and risk factors for COPD.

nosed at later stages of COPD when the disease has progressed because they delayed sharing their early symptoms with their healthcare provider. Everyone with risk factors and those experiencing early warning signs should talk to their healthcare provider about any breathing issues. It's especially important for women to do so. Because COPD has been historically thought of as a "man's disease" or an "old person's disease," women are sometimes misdiagnosed or receive a delayed diagnosis. But overall, more women are affected by COPD than men and the death rate is higher in women. In addition, women tend to develop the disease at a

younger age. To diagnose COPD, the healthcare provider will evaluate symptoms, gather a complete health history, conduct a health exam and perform a pulmonary function test called spirometry. The results of the spirometry test can determine if you have COPD.

•Lifestyle Changes In addition to treatment,

know firsthand. After being diagnosed with stage 2 COPD in the wake of a COVID-19 infection, Bob F. partnered with his doctor and started monitoring his breathing at home and leaned into exercise. His hard work has paid off, with his last pulmonary function test showing that the disease has not progressed, and he is in better overall shape than before.

"Most of the advice you should follow is no different than what doctors tell us all. Eat right, exercise, sleep, drink plenty of water, manage your weight and don't smoke. If you do these things, you may slow the progression of your COPD," says Bob. But you shouldn't wait

until a COPD diagnosis to make these changes. Lifestyle changes like quitting smoking, avoiding secondhand smoke and reducing your exposure to air pollution may reduce your risk for developing COPD. If you are experiencing shortness of breath or other respiratory symptoms, do not delay talking to your healthcare provider about your symptoms or COPD risk factors.
