A Hawk, a Train and Two Drunk Women

If I wrote a book about the strange incidents that I encountered as a police officer here in Columnist Montgomery County, many

people would not believe me. But as Joe Friday, from Dragnet TV fame, used to say..."The stories you are about to hear are true. Only the names have been changed to protect the innocent." Here are just three examples...

One year there had been quite a few residential burglaries in the rural areas of the county. I received a tip one evening from an older fellow who lived in Alamo. A young man had told him that he had been with two men



when they had burglarized a trailer at Indian Ford. Although the young man had not stolen anything himself, he was concerned that he might be in trouble. I spoke with this young man and his mother the next day. He was quite nervous, but eventually told me the names of the thieves and the details of the burglary. Several items, including a

small safe, had been stolen. He correctly named many of the stolen items. One thief had also stolen an expensive pair of name brand sunglasses, and threw his old pair out the car window as they left.

Both of the named suspects refused to come in for questioning, so I needed to corroborate the informant's story. On my day off, my wife and I drove to Indian Ford trailer park to search for the sunglasses. We searched everywhere for two hours. No luck. As I started to head back home, I heard a screeching sound from a nearby tree. I looked up, and guess what I saw? A

All For Democracy, **Democracy For All?**



In 2019, the Knight Foundation set out to understand why nearly 100 million eligible voters sit out one of the "central democratic acts"

for people in the United States - casting a ballot. Their study revealed five key findings, one of which is that disengaged voters have less faith in the electoral system than voters they don't like the candidates and they don't think their vote matters.

This sentiment may not surprise you. It showed up in a local column on June 24, and it's dinner table discussion for many.

The Knight Foundation, which focuses its work in communities where the Knight brothers, John S. and James L., once published newspapers, mostly focuses its work on improving those communities. But civic engagement remains one of their points of interest.

Their study also found that if all the non-voters had shown up in 2020, they'd have split their votes - 33 percent voting Democrat, 30 percent voting Republican and 18 percent voting for a third party. They were closely divided on the Republican candidate, and while they skewed left on healthcare, they are more conservative on immigration and abortion issues.

The study also found that nonvoters are less likely to read a column like this. Or any news for that matter. What they know about current events comes from "bumping into the news." It's reminiscent of latenight TV in the 1990s where "the man on the street" bits put a microphone in the face of Americans who couldn't name key players in national events, including the president and vice president, among others.

How did we get to a point where so many Americans tune out? What does it say about faith in "a government by the people, for the people," a.k.a. democracy?

There's a multitude of reasons many Americans have thrown up their hands. Could it be because they live in a district or state hopelessly gerrymandered or dominated by one party, or because it seems politicians and parties serve their own best interests, ignoring messages that their constituents have views contrary to the party line? Or maybe they're skeptical about career politicians, and feel there's a "tyranny of the minority," as Daniel Ziblatt and Steven Levitsky argue in their book of the same name.



Looking to get rid of that hazardous waste stuff around the house, garage or yard? Then be sure to make Saturday, July 6 on your calendar!

From 8 a.m. to 1 p.m. the Montgomery County Solid Waste Management District will conduct their annual Tox-Away Day at Crawfordsville High School. This Event allows Montgomery County residents to dispose of their Household Hazardous Waste. Regulations prohibit businesses from utilizing this event. Most items are accepted free of charge, unless noted. But if there is a charge, only cash / checks will be accepted.

A listing of general dos and don'ts is included with this story, but here are a few guidelines.

Do not bring documents - there are

no shredding services on Tox-Away Day

No heavy trash items, like furniture, mattresses, construction material, etc.

Don't include traditional recyclables like bottles, cans, plastic,

Don't bring alkaline batteries (AA, AAA, C, D, PV, etc.). Those are non-hazardous.

Tox-Away Day is only for Montgomery County residents. And regulations prohibit hazardous wastes from other organizations (businesses, churches, schools, non-profits, etc.)

LATEX PAINT DISPOSAL PROCESS

Latex paint is water based and nonhazardous. Residents should dry out latex paint by removing the lid, mixing paint with equal parts of cheap kitty litter, sand, oil dry or shredded newspaper. The paint should dry to a solid form in a couple days. Set the dried paint out for trash pick-up with the lid removed. Liquid paint is not accepted by most trash haulers.





Drawing on Aristotle, they argue that the majority cannot be trusted; hence the need for a republic in which representatives serve as intermediaries don't vote, and many others, shouldn't vote shouldn't have the right

In contrast, Ziblatt and democracy is the most reflects the culture and requiring maintenance and adjustment.

In their book The Tyranny of the Majority, Ziblatt and Levitsky address the way in which democracy has evolved around the world, sometimes degenerating to exclude the will of the majority, sometimes maturing to respond to the challenges of balancing the rights of the minority with the will of the majority.

technologies and institutions, from corporations to national healthcare systems to education districts. There's an uncomfortable but necessary dynamism, as citizens adopt these new systems and must realize self-governance in synergy with new tools and evolving communities. The people living in and with these systems experience their consequences and outcomes, and if something doesn't work, their voices and perspectives are critical to ensuring regulations, procedures and laws adapt to protect and

It seems incongruous to believe that freedom for all requires that some citizen's perspectives be discounted or distrusted on the basis that they lack intellectual, economic or moral credentials. Such a position is both exclusive and presumptive. It depersonalizes and disrespects and it creates a shifty, uncertain foundation. Who's in? Who's out?

improve them.

Every citizen should have the right, indeed the responsibility, of voting with as few barriers as possible. A democratic system requires extraordinary faith. We are called to trust others are doing the work, even if they approach it differently.


Who decides?

It requires us to tolerate differences, the selfawareness that humans come at the world with different ways of thinking and to honor reasonable differences about the way the world works.

Ziblatt and Levitsky lay out a case on the dangers of a small group of politically minded people having a mismatched advantage that they leverage against the majority. The minority here is not an ethnic or racial minority, but one with a political identity. Such a group finds itself unified by one aim: to preserve the narrative and way of living that they idealize. While they justify name-calling, canceling, gerrymandering, and

every other tactic to maintain their dominance, they seem blind to the notion that they are squelching the engagement of fellow citizens.
