

You Should Know

- Indiana Attorney General Todd Rokita filed a lawsuit alleging that Mylan and Pfizer have conspired to increase EpiPen's price by more than 600 percent in order to continue to profit from EpiPen prescriptions and prevent other similar products from coming to market and being available to consumers. EpiPens are potentially life-saving devices used to inject adrenaline into patients to combat severe allergic reactions. The complaint alleges the companies and their subsidiaries have violated the Indiana companies and their subsidiaries have violated the Indiana Deceptive Consumer Sales Act, the Indiana Antitrust Act and the Medicaid False Claims Act by continually increasing the price of EpiPens and providing payments to pharmacy benefit managers to exclude competition. The lawsuit also asserts the companies have paid doctors to endorse their decision to launch a 2-pak of the EpiPen and claim it is medically necessary — allowing the companies to cease selling individual EpiPens.
- A recent survey of 3,000 drivers by Gunther VW Daytona identified America's most feared winter roads – and five were in Indiana. The worst in the U.S.? Alaska Rte. 2. And Hoosier highways that hit the ranking included, Interstate 74 at 29th, I-69 at 45th, I-80 / 90 112th, I-70 at 140th and I-65 at 151. To stay safe, they recommend things like slowing down, don't tailgate, brake gently and early, accelerate gradually, steer smoothly and other common sense approaches.
- Our friends at deye.com shared a study of 30 years of weather data that ID'd each state's gloomiest day of the year . . . and in Indiana it turned out to be Jan 30. Key factors like temperature and cloud cover were used to make the determination. And while winter enthusiasts may embrace the season, Jan. 30 is likely to be a day where most Hoosiers would rather stay indoors. With a historical track record of icy temperatures, thick cloud cover, and the general sluggishness of midwinter, it's the perfect storm for  $\,$







## Sen. Buchanan on Property Taxes

The Indiana Senate is working on several bills that would lower Hoosiers' property taxes, said State Sen. Brian Buchanan (R-Lebanon).

In recent years, Buchanan has heard the concerns of residents across Senate District 7 about rising property taxes. Montgomery County, along with portions of Boone, Clinton and Hendricks counties, make up District 7.

"Hoosiers I have talked to are understandably frustrated by the substantial increase in their annual property tax bills," Buchanan said. "That's why my colleagues and I have prioritized offering practical solutions to provide property tax relief for Hoosiers."

This year, Senate Republicans filed Gov. Mike Braun's property tax proposal as Senate

The bill will likely see changes throughout the legislative process, but

the goal of providing property tax relief for Hoosiers will guide discussions.

"As a member of the Senate Committee on Tax and Fiscal Policy, I look forward to being part of many conversations with property owners, local leaders and legislators in our efforts to enact meaningful property tax reform," Buchanan said.

Buchanan has also authored two bills that would tackle property tax issues in Indiana.

Senate Bill 7 would change the property tax assessment formula for agricultural land specifically the component known as the capitalization rate - to lower property taxes for farmers. In its current form, the bill would save Hoosier farmers an estimated \$46 million in property taxes per year.

"We are looking at making a few small adjustments to the formula for agricultural land, which will help those involved in production agriculture,"

Buchanan said. "SB 7 is one part of the larger discussion about property taxes this session."

Senate Bill 8 would require a school referendum be placed on the ballot only during non-municipal election years, a one-year "cooling off" period after a referendum ends before another can be requested to be placed on the ballot and require districts to provide the total amount of property tax revenue expected to be collected each year.

human identity, cognitive skills and emotional maturity. The first is from 0-5 years old. The second begins in the adolescent years, with start times varying, but lasting from 12-25 years old broadly.

It should be no surprise then, that at least one-third of college students change majors at least once, according to Inside Higher Ed. The National Center for **Education Statistics** reported in 2017 that, "the rate at which students changed majors varied by their original field of study. Whereas 35 percent of students who had originally declared a science, technology, engineering, or mathematics major had changed their field of study within three years, 29 percent of those who had originally declared a non-STEM major had done so."

An 18-year-old declares biology major intending to be pre med may end up in accounting, or history, or philosophy or finance. Harvard **Business Review** reported in 2022 that only 27 percent of college grads work in a field closely related to their major.

It seems that humans don't follow linear job or career paths. For this reason, professional educators have resisted "tracking" students for workforce, college or military, an idea that's been floated as far back as Plato in The Republic and treated with skepticism in Aldous Huxley's Brave New World. Yet Timmons, parents and educators are concerned that Hoosier politicians and IDOE professionals have leaned into such tracking with the new diploma tracks.

In early drafts of the new requirements, Purdue's President Mung Chiang, and other college leaders, pushed against the change, saying that Hoosier students would be even less qualified for admission to competitive schools like Purdue. Legislators and IDOE tightened

modified the base diploma to make students less equipped for non-linear life paths. The base diploma,

tentatively called the "Future New Indiana Diploma," is similar to the current Core 40 diploma with some modifications: eight credits of English, including a communications-based course; math requirements include Algebra 1 and a personal finance class, plus four additional math credits; social studies requirements replace economics and world history with a "world perspectives" requirement; 12 credits of student choice electives, which can be used to pursue seal pathways.

Students can earn up to three honors seals in addition to the base diploma: an honors enrollment seal, honors employment seal and honors enlistment seal. These are designed to help ninth graders and their parents make a path through high school.

The honors enrollment seal resembles the current Core 40 with Academic Honors diploma. It helps students who think they will attend college. It requires four credits of world languages and six credits of social studies, eight math credits and six science credits. Students must earn at least a C in all courses and maintain a B average. Additional requirements include AP, IB or college credits, or minimum SAT / ACT scores.

The honors employment seal requires 100 hours of work-based learning and completion of a "market-driven credential of value" or three courses in a career and technical education pathway. Students must demonstrate communication, collaboration and work ethic skills. It is designed to help young people who want to go directly into the workforce with proof of employability.

minimum score of 31, the minimum for Army enlistment. Students must complete an introduction to public service course or one year of JROTC and be mentored by veterans or current military personnel.

Each seal also has a "Plus" tier with more advanced requirements, including additional coursework, work experience, or higher test scores.


The new diploma system, adopted in 2024, will begin with the Class of 2029.

Maybe they're being pragmatic. After all, plenty of educators hear parents bemoan why their kids need to learn algebra, and certainly adding personal finance into the curriculum is a life skill. While many people will not literally solve for X or Y in their careers, they have to solve problems with unknowns and think abstractly, especially in an increasingly technical workplace. They may not have drawn a straight line from "I need to earn X number of dollars, minus taxes, housing, utilities and transportation. So can I afford to buy this?" but they were using abstract, algebraic thinking. That life question involves both personal finances and a wild number of X, Y and other unknowns that change across the years of life.

It's why so many teachers and parents have long told young people "We're teaching you how to problem solve, how to think, not what to think."

Next week, Chip Timmons will offer deep insights in the change.

The problem is complex. While Indiana has some of the country's lowest property taxes for homeowners, including ranking No. 5 in the nation for best property tax climate according to the Tax Foundation, many Hoosiers have been understandably frustrated by the considerable year-overyear increases in their bills, which have largely been caused by inflation.

Property taxes, which are set and used solely by local governments not the state government – fund local services like schools. police and fire departments. That's why it's so important to balance lowering taxes on Hoosier homeowners, farmers and businesses with funding the needs of schools and local governments.

In its current form, Senate Bill 1 - our caucus's top priority bill - reflects Gov. Braun's plan to cut property taxes. The bill is likely going to change throughout the legislative process as the Senate, House of Representatives and the governor work together to find a plan that will work best for property owners and local governments beginning in 2026.

This work builds on our previous efforts to cut

property taxes for homeowners and is sure to be one of the most discussed issues this session

#### **LEGISLATIVE UPDATE**

- Senate Bill 121, would protect our rivers from destructive net fishing practices stemming from our country's failed immigration policies. It passed the Senate Committee on Natural Resources Monday with bipartisan support. A video filmed by a Montgomery County constituent shows the problem I am trying to solve.
- Senate Bill 122, is a small-government, "teach-a-man to fish" approach to fighting poverty. It would allow state employees undergoing financial emergencies to use payroll deduction to get lower rates on small dollar loans from charitable driven, non-profit loan centers that are an alternative to payday loans. This bill was heard during a meeting of

the Senate Committee on Insurance and Financial Institutions Wednesday and is expected to be

voted on soon.

· Senate Bill 255, would help our schools recruit more qualified STEM teachers and also force them to change their policies on bullying investigations to prioritize parental rights. It was heard during a meeting of the Senate Committee on Education and Career Development Wednesday and is expected to be

voted on next week.
