

Ask Rusty – Ask Rusty – Can Spouses **Get Benefits From Each Other?**

Dear Rusty:

My wife and I are currently collecting Social Security. We both started receiving SS at 62 years old. That said, we get by on a tight budget. A retired friend told us about an option which allows a spouse to collect half (1/2) of the other spouse's SS monthly income. My question has two parts: 1. Can we both collect on each other's SS? And 2. Are there any pitfalls? Signed: Seeking an

Increase

Dear Seeking: Well, I'm afraid spousal benefits aren't quite that simple. One spouse may be eligible for additional benefits from the other, but only if that spouse's personal Social Security retirement benefit at their full retirement age (FRA) is less than half (50%) of the other spouse's FRA entitlement. Note that for spouse benefits, FRA

amounts are used regardless of when you actually claim benefits. Full retirement age for both you and your wife is 66, so that means that if you both claimed at 62 your FRA entitlements were higher - about 25% more - than you are both currently receiving.

Since you applied for benefits some time ago at about the same age, one way to estimate if one of you may be entitled to an additional amount as a spouse is to evaluate your current monthly amounts. If either of you are getting a benefit which is less than half of the other's amount, it's possible that the one with the lower benefit may be entitled to more as a spouse. And note, only one spouse is eligible for benefits - you cannot both get spouse benefits from each other.

Safely Dispose of **Prescription Drugs at Drug Take Back Day**

On Saturday, April 26, the Harm Reduction Committee of the Montgomery County Drug Free Coalition will host the biannual Prescription Drug Take Back event from 10 a.m. to 1 p.m. in the parking lot of First Christian Church at 211 S. Walnut St. in Crawfordsville.

This free event provides the opportunity to carefully dispose of expired, unused or unneeded prescription drugs and over-thecounter medications.

What can happen if you keep old prescriptions and other medications around the house? Expired medications can be less effective or risky from a change in the chemical composition or a decrease in strength. Certain expired medications are at risk of bacterial growth and sub-potent antibiotics can fail to treat infections, leading to more serious illnesses and antibiotic resistance.

According to the DEA, many people don't know how to properly clean out their

medicine cabinets and failing to dispose of old medications, especially opioids, can often lead to dangerous drugs ending up in the wrong hands. Reducing the misuse of these expired medications can play a key role in combating the substance abuse issue often serving as a gateway to using more harmful substances.

Can't attend this event? Don't worry! Prescription drug disposal is also available year-round at the Montgomery County Sheriff's Office and the Crawfordsville Police Department.

The Harm Reduction Committee would also like to highlight the importance of proper disposal for not only medication, but for sharps / needles. Sharps can be safely disposed of at the Montgomery County Health Department, located at 1580 Constitution Row, Suite G and at the Crawfordsville Police Department lobby, located at 311 N. Green St

better outcomes across multiple types of surgery.

This makes the current approach to choosing surgical care deeply concerning. Research shows that most patients select hospitals based on data-free factors like word-of-mouth recommendations or doctor referrals. These recommendations and referrals aren't always completely objective, especially as health systems increasingly pressure physicians to refer patients within their own systems.

Patients can become their own best advocates -- by examining the data in five critical areas.

First, look at success rates -- how well patients actually recover. The best hospitals track and share their patients' improvements in quality of life, pain levels, and function after surgery.

Second, examine patient experience scores. They contain a wealth of information about how well a hospital communicates, coordinates care, and supports patients through their journey.

Third, dig into complication rates. Find out how often things go wrong and how well the hospital handles the challenges that arise.

The fourth factor, readmission rates, is particularly telling. How often do patients end up back in the hospital unexpectedly? Low rates of readmission signal that a hospital excels at preventing complications and managing the overall process of recovery.

hospital performs. Experience matters, and high-volume centers tend to deliver better results.

Together, these five measures paint a clear picture of hospital quality -- and should be readily available to any patient considering surgery. Yet all too often this information is difficult or impossible to find.

Currently, there are few resources available to patients interested in comparison shopping. While the Centers for Medicare & Medicaid Services provides some hospital comparison tools, they're clunky and incomplete. Private insurers have detailed data on their providers' outcomes, but many choose not to share it.

Easier access to comparisons would be game-changing both for patients and the healthcare system as a whole. Just as vehicle safety ratings spurred car makers to compete on crash protection, surgical outcome transparency could drive providers to improve their results. Research suggests that simply publishing complication rates motivates hospitals to enhance their safety practices.

Patients scheduling surgery shouldn't settle for less information than they'd want when buying a car -- and our healthcare system shouldn't make finding it any harder than reading a window sticker.

Another way to explore this is for the spouse with the lowest monthly Social Security benefit to contact Social Security at 1.800.772.1213 to ask if spouse benefits are available. Noting that contacting SS these days can be a timeconsuming process, yet another way is for you to provide us (the AMAC Foundation's SS Advisory Service) with both of your current monthly SS benefit amounts (before any deductions) and the exact ages when each of you claimed. Using that information, we can do the math to see if either of you might be entitled to more as a spouse. But, in the end, only the spouse with

the lower benefit may be eligible, and then, entitlement (not their actual current amount) is less than 50% of the other spouse's FRA entitlement.





Water Supply Legislation Passes House

The Indiana House recently passed legislation to safeguard Hoosiers' water supply and improve oversight on how it's regulated, according to area lawmakers.

"Indiana continues to see increasing demand for water through new economic development and agricultural and residential needs," said State Rep. Mark Genda (R-Frankfort). "This legislation is a step in the right direction to make sure we're balancing those needs while protecting the water supply for our communities."

State Rep. Matt Commons (R-Williamsport) said the legislation is in part a response to water concerns associated with the Indiana Department of Economic **Development's LEAP** Lebanon Innovation District. Tenants at the industrial park expect to need more water than is locally available. An initial proposal to build a 50mile pipeline from **Tippecanoe County** capable of transferring 100 million gallons a day was shelved so the Indiana Finance Authority could study its feasibility. Citizens Energy Group has since committed to utilizing their 10 water treatment plants and other resources to supply the LEAP District with the water they need without a

Regulatory Commission before any pipeline construction begins.

In addition, the legislation would prohibit individuals from transferring substantial amounts of water out of a basin or restricted use area without first obtaining a transfer permit from the Indiana Department of Natural Resources. This would address concerns of unrestricted water transfers negatively impacting water sources for local industries, agriculture and residents.

To further protect Indiana water, Senate **Enrolled Act 28** provides a way for owners and operators of Significant Groundwater Withdrawal Facilities (SWWFs), such as household wells, whose water supply is not at its normal level or potable, to file a complaint with the director of the Indiana Department of Natural Resources. The director will investigate the complaint within three business day. SWWF owners found responsible for the failure or substantial impairment of wells must provide timely and reasonable compensation to the well's owner.

Despite ESPN Blunder, Purdue's Braden Smith Getting Deserved Attention

Today, the **Bob Cousy** Award. Tomorrow? Maybe the Wooden

It's heady times for former Indiana Mr. Basketball Braden Smith, who took home the award as the nation's best point guard during Final Four Week in San Antonio.

Presuming Smith returns to Purdue for his senior season, some national media members think he could join former teammate Zach Edey as the national player of the year in 2025-26. More on that later.

Winning the Cousy Award marks the third player recruited by Matt Painter to win one of the five position awards. Carsen Edwards took home the Jerry West Award as the nation's top shooting guard in 2018. Edey won two consecutive Kareem Abdul-Jabbar Awards given to the nation's top center.

Purdue also should have had a Karl Malone Award winner in power forward Caleb Swanigan in 2017. Voters instead gave the honor to Baylor junior Johnathan Motley, even though Swanigan had better statistics. Swanigan averaged 18.5 points and 12.5 rebounds during his Big Ten Player of the Year season. Motley put up 17.3 points and 9.9 rebounds.

Maybe Trey Kaufman-Renn makes up for that slight in 2025-26.

Smith puts Purdue with Gonzaga, Duke and Kentucky as the only schools to have three different players win their respective positional trophy.

"To be included among the elite players that have won this award is very humbling and I am grateful to be selected to join that prestigious group," Smith said.

Smith will enter his senior season needing just 125 points and 242 assists to become the first player in NCAA history with 1,500 points, 1,000 assists and 500 rebounds for his career. Bobby Hurley's career assists record of 1,076 is within Smith's reach as well. Smith needs 318 assists, five more than his school record total this season.

Unfortunately for Smith and Purdue fans, ESPN managed to screw up the Cousy Award announcement.

The supposed "Worldwide Leader in Sports" ran a video package of Creighton center Ryan Kalkbrenner, who at 7-1 will never be mistaken for a point guard, instead of Smith's highlights.

Anchor Rece Davis immediately corrected the error. Later on social media, Davis said "a wrong tape rolled." The correct tape never aired, though. Not a surprise coming from a network that ignores

leagues whose rights it doesn't own.

Great expectations

Now that the college basketball nation outside of ESPN believes in Braden Smith, Purdue is a national championship favorite in 2025-26.

The most confident forecast comes from The Athletic, where writer C.J. Moore picks the Boilermakers No. 1 in his way-too-early Top 25.

"Talent plus roster continuity is a winning formula, and no team has a better combination of that at this moment than Purdue," Moore writes. "This will be the only team returning a firstteam AP All-American in Braden Smith, not to mention an honorable mention in forward Trey Kaufman-Renn. When Houston prepped for Purdue in the Sweet 16, the Cougars' coaches took to calling Smith, Kaufman-Renn and Fletcher Loyer "Stockton, Malone and Hornacek."

John Stockton and Karl Malone of the Utah Jazz were members of the first Olympic Dream Team in 1992 and have been enshrined in the Naismith Memorial Basketball Hall of Fame. Jeff Hornacek was an NBA All-Star guard for Phoenix, Philadelphia and Utah and a twotime winner of the NBA Three-Point Contest. All three had their numbers retired by the

Jazz.

Smith heads a projected starting lineup of fellow seniors Trey Kaufman-Renn and Fletcher Loyer, transfer center Oscar Cluff and sophomore C.J. Cox.

Cluff, a 6-11 center from Sunshine Coast, Australia, signed with Purdue last week. Cluff was ranked the No. 1 transfer in the nation by On3.com. Cluff averaged 17.6 points, 12.3 rebounds (second place nationally) and 2.8 assists for South Dakota State. Notably, Cluff shot 63.4 percent from the field and 77.8 percent at the free throw line.

One of Cluff's best games last season saw him put up 21 points and 15 rebounds in a loss at Alabama. "Coach Matt Painter added a veteran big who is an elite rebounder in South Dakota State transfer Oscar Cluff," Moore writes. "Daniel Jacobsen could emerge as the next star Purdue big and could provide the rim protection this season's group missed without Zach Edey. It's also possible Purdue could add one perimeter player or more, which would strengthen the Boilers' preseason No. 1 case." Florida, Houston, Louisville and Michigan round out Moore's top five. Big Ten teams ranked by Moore are Michigan State (7th), UCLA (20th), Illinois (21st) and Ohio State (24th).

Jeff Borzello of ESPN.com has Houston ahead of Purdue based heavily on three freshmen rated in the top 20 by its recruiting rankings.

"There's a chance Purdue has the preseason Wooden Award favorite and two All-Americans on its roster next season," Borzello writes. "Braden Smith will be the best guard in the country after taking the next step in his development this past season, and Trey Kaufman-Renn is a dominant paint force. The addition of South Dakota State transfer Oscar Cluff should help inside, and a healthy Daniel Jacobsen could be poised for a breakout season."

Borzello's top five features Louisville at No. 3, followed by Connecticut and Michigan. Other Big Ten schools in the ESPN rankings are UCLA (10th), Wisconsin (14th), Michigan State (18th) and Ohio State (23rd).

Kevin Sweeney of SI.com also has Purdue second behind Houston.

"Purdue can essentially start on third base this offseason if it can retain its strong nucleus from 2024-25. Point guard Braden Smith and forward Trey Kaufman-Renn profile as likely All-Americans as seniors, while third option Fletcher Loyer is on track to score over 1,500 points as a Boilermaker. And while the Boilermakers have traditionally not been active in the portal, coach Matt Painter has already made one dynamite addition with double-double machine Oscar Cluff to help solidify a weak frontcourt. They could add another piece or two to boost their athleticism and size on the wings."

Illustrated peers, noting Purdue "should have as much returning experience and perimeter firepower as anybody in the sport next season." Fanta has UCLA ranked ninth, Michigan 15th, Michigan State 18^{th} and Iowa 25^{th} .

Did you know?

Since Memphis Grizzlies coach Taylor Jenkins was fired March 28, Purdue great Zach Edey has seen his playing time, and production, increase.

In a 124-100 victory against the Charlotte Hornets on Tuesday, Edey recorded his 12th double-double with 17 points and 19 rebounds in 31 minutes.

The previous game, a 109-103 victory against Detroit, saw Edey set the franchise rookie record with 21 rebounds. Edey is the first rookie since Shaquille O'Neal in 1993 to total 40 or more rebounds in a two-game span.

Over the last four games, during which Memphis went 3-1, Edey has averaged 10.3 points and 15.7 rebounds in 30 minutes a game.

increased Edey's scoring average to 9.3 and his team-leading rebounding average to 8.2. As of Wednesday, Memphis was in a four-way tie for fourth place in the Western Conference at 47-32.
